A BILL

To amend title 18, United States Code, to protect federally funded public safety officers.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 **SECTION 1. SHORT TITLE.**
- 4 This Act may be cited as the "Justice for Public
- 5 Safety Officers Act".
- 6 SEC. 2. FINDINGS.
- 7 Congress finds the following:

1	(1) State and local prosecutors are the best
2	equipped prosecutors to prosecute crimes against
3	local and State peace officers.
4	(2) Cases involving the murder of local and
5	State peace officers and subsequent flight to avoid
6	prosecution in the United States implicate Federal
7	interests, and by providing Federal jurisdiction in
8	such cases the Federal Government will be able to
9	provide additional investigatory and prosecutorial re-
10	sources.
11	(3) The United States should use all reasonable
12	tools available to encourage foreign countries to
13	change their extradition policies so that the possi-
14	bility of capital punishment or life imprisonment will
15	not interfere with the timely extradition of fugitives
16	of the United States.
17	SEC. 3. PROTECTION OF FEDERALLY FUNDED PUBLIC
18	SAFETY OFFICERS.
19	(a) Offense.—Chapter 51 of title 18, United States
20	Code, is amended by adding at the end the following:
21	"§ 1123. Killing of federally funded or Federal law en-
22	forcement officers
23	"(a) Offense.—Whoever kills, or attempts or con-
24	spires to kill, a federally protected safety officer while that
25	officer is engaged in official duties, or on account of the

1	performance of official duties, or kills a former federally
2	protected safety officer on account of the past perform-
3	ance of official duties as such, shall be punished—
4	"(1) in the case of murder, as provided under
5	section 1111 but not less than 30 years;
6	"(2) in the case of attempted murder, as pro-
7	vided in section 1113 but not less than 15 years; or
8	"(3) in the case of manslaughter, as provided
9	under section 1112.
10	"(c) Definitions.—As used in this section —
11	"(1) the term 'federally protected safety officer'
12	means a public safety officer for a public agency (in-
13	cluding a court system, the National Guard or a
14	State to the extent the personnel of that National
15	Guard are not in Federal service, and the defense
16	forces of a State authorized by section 109 of title
17	32) if —
18	"(A) if the public agency receives, in any
19	one year period, funding, equipment, or benefits
20	in excess of \$10,000 under a Federal program
21	involving a grant, contract, subsidy, loan, guar-
22	antee, insurance, or other form of Federal as-
23	sistance, and the public agency is of an entity
24	that is a State of the United States, the Dis-
25	trict of Columbia, the Virgin Islands of the

1	United States, Guam, American Samoa, the
2	Trust Territory of the Pacific Islands, the Com-
3	monwealth of the Northern Mariana Islands, or
4	any territory or possession of the United States,
5	and Indian tribe, or a unit of local government

7	"(B) the officer was at the time of the of-
8	fense, engaged in carrying out a program au-
9	thorized by Federal law or regulation that is ex-
10	ecuted in whole or in part by non-Federal pub-
11	lic safety officers;
12	"(2) the term 'public safety officer' means an
13	individual serving a public agency in an official ca-
14	pacity, as a judicial officer, as a law enforcement of-
15	ficer, as a firefighter, as a chaplain, or as a member
16	of a rescue squad or ambulance crew;
17	"(3) the term 'judicial officer' means a judge or
18	other officer or employee of a court, including pros-
19	ecutors, court security, pretrial services officers,
20	court reporters, and corrections, probation, and pa-
21	role officers;
22	"(4) the term 'firefighter' includes an individual
23	serving as an official recognized or designated mem-
24	ber of a legally organized volunteer fire department
25	and an officially recognized or designated public em-

1	ployee member of a rescue squad or ambulance crew;
