**July 2005** 

Total number of bills and resolutions signed into law in July 2005: 24

**Total costs of bills signed into law in July 2005:** 

- Authorizations over five years: \$276.0 million
- Net change in mandatory spending over five years: +\$240.0 million
- Appropriations for fiscal year 2005: \$0
- Appropriations for fiscal year 2006: **\$0**
- Net change in federal revenue over five years: -\$12.0 million

#### H.R. 3021

Public Law 109-19

To reauthorize the Temporary Assistance for Needy Families block grant program through September 30, 2005

Signed into law: July 1, 2005

Cost: Increases mandatory spending by \$240.0 million over five years

Public Law 109-20

Surface Transportation Extension Act of 2005, Part II

Signed into law: July 1, 2005

<u>Cost</u>: Increases contract authority (a mandatory form of budget authority) by \$205.0 million over five years

Signed into law: July 27, 2005

# **H.J.Res. 52**

Public Law 109-39

Approving the renewal of import restrictions contained in the Burmese Freedom and Democracy Act of 2003

Signed into law: July 27, 2005

Cost: Reduces revenues by \$12.0 million over five years

Cost: Authorizes \$71.0 million over five years
