2. MONATANA, CHAIRMAN, COMMITTEE ON FINANCE 3 The Chairman. Today, the Finance Committee meets to consider the nomination of Douglas H. Shulman to be 5 6 Commissioner of Internal Revenue. I support his 7 nomination. 8 At Mr. Shulman's nomination hearing on January 29 of 9 this year, I highlighted many of the challenges that he will face as IRS Commissioner. These include the tax 10 gap, improving customer service at the IRS, IRS's 11 12 outdated computers, a global economy, an aging IRS 13 workforce, fundamental tax reform, and implementing 14 stimulus this year. 15 I told Mr. Shulman that these challenges also 16 represented opportunities to turn the IRS around. During 17 the hearing, Mr. Shulman's responses demonstrated that he 18 had given each of these challenges some thought. 19 I asked for his commitment that he would provide 20 strong leadership to take on these issues and to effect 21 change at the IRS. Mr. Shulman gave his "absolute commitment." He said he was "100 percent committed" to 22 23 working with me to increase compliance and to help close 24 the tax gap. 25 I was pleased to hear that Mr. Shulman recognized

- 1 that compliance rates are highest when there is third-
- 2 party information reporting. And I was pleased that he
- 3 is looking forward to working in close partnership with
- 4 me on that issue.
- I was encouraged to hear Mr. Shulman say that
- 6 modernizing outdated IRS technology would be a priority
- 7 for him.
- I was heartened to hear Mr. Shulman say that he
- 9 would do everything in his power to ensure that the
- 10 stimulus checks go out as quickly as possible.
- Once confirmed, he has a big job ahead of him.
- Mr. Shulman has my support. But with that support
- 13 comes accountability.
- I told Mr. Shulman that every time he comes before
- the Finance Committee, I'm going to ask him to provide an
- 16 accounting of his progress in closing the tax gap. I am
- going to go down this list of challenges again and again.
- 18 I put him on notice that I expect him to demonstrate
- 19 specific and real progress each and every time I pose the
- 20 question. I don't want to hear "we are working on that."
- 21 I want to hear real results.
- I appreciate that Mr. Shulman is willing to take on
- 23 these challenges. I thank him for agreeing to serve our
- Nation in the difficult job of IRS Commissioner. I wish
- 25 him well as he takes on this new role and look forward to

- 1 working with him throughout his tenure.
