1 "(c) APPLICATIONS.—Each nonprofit organization, 2 State educational agency, local educational agency, or institution of higher education desiring a grant under this 3 4 section shall submit to the Secretary an application that 5 contains a plan to initiate, expand, or improve environ-6 mental education programs in order to make progress to-7 ward meeting State standards for environmental learning 8 (to the extent such standards exist) and environmental lit-9 eracy and contains an evaluation and accountability plan for activities assisted under this section that includes rig-10 11 orous objectives that measure the impact of activities funded under this section. 12

13 "(d) REQUIREMENTS.—

"(1) ANNUAL REPORT.—In order to continue
receiving grant funds under this section after the
first year of a multi-year grant under this section,
the grantee shall submit to the Secretary an annual
report that—

19 "(A) describes the activities assisted under
20 this section that were conducted during the pre21 ceding year;

22 "(B) describes the results of the grantee's23 evaluation and accountability plan; and

1	"(C) demonstrates that the grantee has
2	undertaken activities to accomplish at least one

7	ing the supply of clean energy, climate
8	change, environmental health risks, and
9	environmental disaster and emergency pre-

16	"(iii) Helping ensure that all students
17	meet challenging State academic content
18	and student academic achievement stand-
19	ards in environmental learning.
20	"(iv) Supporting efforts to enable stu-
21	dents to engage in environmental edu-
22	cation.
23	"(v) Leveraging and expanding pri-
24	vate and public support for environmental

1	education partnerships at national, State,
2	and local levels.
3	"(vi) Awarding grants to initiate, ex-
4	pand, or improve environmental education
5	programs for elementary and secondary
6	students.
7	"(vii) Restoring and increasing field
8	experiences as part of the regular school
9	curriculum and schedule in order to im-
10	prove students' overall academic perform-
11	ance, self-esteem, personal responsibility,
12	community involvement, personal health
13	(including addressing child obesity issues),
14	and understanding of nature.
15	"(2) Administrative expenses.—Not more
16	than 5 percent of the grant funds made available to
17	a nonprofit organization, State educational agency,
18	local educational agency, or institution of higher
19	education under this section for any fiscal year may
20	be used for administrative expenses.
21	"(3) STATE ENVIRONMENTAL LITERACY
22	PLANS.—
23	"(A) IN GENERAL.—A State educational
24	agency receiving a grant under this section
25	shall—

1	"(i) have a State environmental lit-
2	eracy plan that is consistent with the re-
3	quirements of subsection $(b)(6)$ and that is
4	peer reviewed within the State by a panel
5	composed of experts in environmental edu-
6	cation and representatives from other re-
7	lated State agencies; or
8	"(ii) develop a State environmental
9	literacy plan described in subsection $(b)(6)$
10	with funds made available under this sec-
11	tion prior to using the grant funds for any
12	other purpose.
13	"(B) PEER REVIEW.—If an environmental
14	literacy plan described in subparagraph (A)(i)
15	has not been peer reviewed within the State, the
16	State educational agency, notwithstanding sub-
17	section (b), shall use funds made available
18	under this section to complete such review, as
19	described in such subparagraph, prior to using
20	the grant funds for any other purpose.
21	"(C) Other grantees.—An applicant for
22	a grant under this section that is not a State
23	educational agency and applies for funding to
24	be used for the purpose described in subsection
25	(b)(6) shall demonstrate in the application that

1	the applicant has consulted with the State edu-
2	cational agency about such use of funds.
3	"(e) Administrative Provisions.—
4	"(1) FEDERAL SHARE.—The Federal share
5	under this section shall not exceed—
6	"(A) 90 percent of the total cost of a pro-
7	gram assisted under this section for the first
8	year for which the program receives assistance
9	under this section;
10	"(B) 75 percent of such cost for the sec-
11	ond; and
12	"(C) 50 percent of such cost for each sub-
13	sequent such year.
14	"(2) Report to congress.—Not later than
15	one year after enactment of this bill, the Secretary
16	shall submit to the Committee on Education and
17	Labor of the House of Representatives and the Com-
18	mittee on Health, Education, Labor, and Pensions
19	of the Senate a report that—
20	"(A) describes the programs assisted under
21	this section;
22	"(B) documents the success of such pro-
23	grams in improving national and State environ-
24	mental education capacity; and

"(C) makes such recommendations as the
 Secretary determines appropriate for the con tinuation and improvement of the programs as sisted under this section.

5 "(3) AVAILABILITY OF FUNDS.—Amounts made
6 available to the Secretary to carry out this section
7 shall remain available until expended.

8 "(f) SUPPLEMENT, NOT SUPPLANT.—Funds made
9 available under this section shall be used to supplement,
10 and not supplant, any other Federal, State, or local funds
11 available for environmental education activities.

12 "(g) RULES OF CONSTRUCTION.—

13 "(1) IN GENERAL.—Nothing in this section
14 shall be construed to mandate academic content
15 standards, curricula, or assessments in environ16 mental education.

"(2) OFFICERS AND EMPLOYEES.—Nothing in
this section shall be construed to authorize an officer
or employee of the Federal Government to mandate,
direct, or control a State, local educational agency,
or school's specific instructional content, academic
achievement standards, assessments, curriculum, or
program of instruction.

"(h) AUTHORIZATION OF APPROPRIATIONS.—There
 are authorized to be appropriated to carry out this section
 such sums as may be necessary for fiscal year 2009.".

4 (d) CONFORMING AMENDMENT.—The table of con5 tents in section 1(b) of the National Environmental Edu6 cation Act (20 U.S.C. 5501 note) is amended by striking
7 the item relating to section 11 and inserting the following:
"Sec. 11. National capacity environmental education grant program.
"Sec. 12. Authorization.".

Amend the title so as to read: "A bill to reauthorize and enhance the National Environmental Education Act, and for other purposes.".
