"NO" on Gonzales

This week I voted against Alberto Gonzales' confirmation as the next U.S. attorney general. I studied his record, reviewed his testimony before the Senate Judiciary Committee, and concluded that he does not meet the standards required to be attorney general.

Though I do not relish voting against any president's cabinet nominees, the position of attorney general is unique in our system of government, and I take seriously my constitutional responsibility to provide advice and consent. The attorney general has a direct impact on the rights, lives, and liberties of every American. More than an advisor to the president, he is the chief law enforcement officer of our country. He may even be called on to investigate wrongdoing by the very president who appointed him.

Because of these unique responsibilities, an attorney general must meet certain standards, including **independence**, an **ability to ensure public confidence**, and **honesty**.

Unfortunately, a review of Mr. Gonzales' record in Texas, at the White House, and before the Senate Judiciary Committee shows he does not meet these criteria. The most troubling example of his lack of <u>independence</u> is his work redefining torture in two infamous 2002 memos. Mr. Gonzales approved standards of torture that defy U.S. law, international agreements, and the Constitution.

I'm also concerned that he would not <u>ensure public</u> <u>confidence</u> in our legal system. Scrutiny of his work on Texas death row clemency appeals shows that, as then-Governor Bush's counsel, Mr. Gonzales left out exculpatory evidence and key facts that might have warranted further review of numerous clemency requests. If Mr. Gonzales was careless in protecting the due process rights of individuals as a governor's counsel, how can we expect him to be more careful as America's attorney general?

Finally, his appearance before the Judiciary Committee raises serious questions about his <u>honesty</u>. During his testimony, he refused to answer many questions. When he did answer, his responses were at times misleading or incomplete.

While Mr. Gonzales's personal story is inspiring, I cannot overlook these troubling aspects of his background. I thus felt it was my duty to vote against his confirmation. Yesterday, Mr. Gonzales was confirmed 60-36.

Don't Privatize Social Security

On Wednesday, I spoke on the Senate floor about the need to strengthen Social Security – and the need to stop the president's risky plan to privatize Social Security. The president's approach would do nothing to save the system, but it would gamble Social Security's guaranteed benefit on the stock market.

Social Security has pulled seniors from poverty. It's an insurance program with a guaranteed benefit that all Americans can count on. But I'm very concerned that President Bush's "restructuring" will imperil the security of all Americans – from young workers retiring in decades to seniors retiring today.

Specifically, the president's proposal:

- Ends guaranteed benefits.
- Does nothing to fix the long-term issues the system faces.
- Adds trillions of dollars to our national debt.
- Is dangerous.

There is a better alternative. I believe we must:

- Preserve Social Security's guaranteed benefit
- Preserve Social Security's protections for workers when they are disabled
- Protect against benefit reductions for women, minorities and all others
- Protect our budget from ever growing deficits

In my floor speech on Thursday morning, I also spoke about the unique impact of Social Security on women. Then I visited the memorial to President Franklin Roosevelt, where I spoke at a press conference re-affirming my commitment to fight for the values he championed. Current and future retirees need someone to stand up for them, and when I see something that's going to hurt our workers, our families, and our seniors, you can bet I'm going to fight it with everything I've got.
