## NEARLY 3 MILLION UNEMPLOYED WILL BE HELPED IF FEDERAL UNEMPLOYMENT BENEFITS ARE EXTENDED

Failure to Restart Federal UI Benefits Will Leave the Unemployed with No Safety Net

Washington, D.C. – If Congress extends the TEUC program for six months and retroactively extends benefits to people who have exhausted regular benefits over the last three months, the **Joint Economic Committee (JEC) Democrats** estimate that nearly 3 million jobless workers would be helped.

From December 2003 through the end of March 2004, an unprecedented number of individuals – an estimated 1.1 million jobless workers – will have exhausted their regular state unemployment benefits without receiving additional aid, according to a report released last week by the Center on Budget and Policy Priorities. The JEC Democrats have done a state-by-state analysis estimating that an additional 1.7 million unemployed workers will exhaust their regular state jobless benefits over the next six months, from April to September 2004 (see table).

"The unemployed are exhausting their jobless benefits at an extremely high rate," said **Rep. Pete Stark** (D-CA), **Senior Democrat** on the JEC. "The one thing we can do for unemployed workers right now is to restart federal jobless benefits and hopefully head off financial ruin for these families."

The Temporary Extended Unemployment Compensation (TEUC) program was created two years ago to provide additional weeks of temporary federal unemployment benefits to jobless workers who have exhausted their regular, state-funded unemployment benefits and are still without a job. After being extended twice, TEUC began phasing out in late December 2003 and individuals who have run out of their regular state jobless benefits since then have not been eligible for federal benefits.

"Treasury Secretary Snow has said that President Bush would sign an extension of temporary federal unemployment benefits if a bill reached his desk," said **Rep. Stark**. "What is the Republican Congressional leadership waiting for – another two million people to run out of their state benefits?"

The Joint Economic Committee, established under the Employment Act of 1946, was created by Congress to review economic conditions and to analyze the effectiveness of economic policy.
