Economic Growth, Job Creation, Tax Relief

The tax relief enacted since 2001 has put money back into Americans' hands and the result has been strong economic growth and job creation.

- ➤ Republicans have enacted four major tax relief packages under the leadership of President Bush. American taxpayers from every walk of life have benefited from rate reductions, an increased child tax credit and marriage penalty relief.
- > Small businesses, manufacturers and other job creators have responded to Republican tax relief by hiring more workers.
- ➤ Our men and women in uniform received needed tax relief as a result of the Military Family Tax Relief Act of 2003. At a time when our military families are making great sacrifices for our nation, it is only right to provide them with tax fairness that decreases their financial burden.

Opening Markets for American-Made Products

After nearly a decade with few comprehensive free trade agreements, Congress empowered the President with negotiating power to open new markets to U.S. exports and create more American jobs.

- The Administration has opened access to new markets for U.S. products and services and restored America's stature in the international marketplace.
- ➤ These agreements create new opportunities for U.S. farmers, businesses, consumers and workers. Most recently, the House passed legislation to eliminate European Union sanctions on American products and provide a level playing field so U.S. businesses can succeed in the worldwide economy.

Improving Health Care and Enhancing Retirement Security

As our nation prepares for the retirement of the baby boomer generation, Congress has worked to strengthen health care and retirement benefits.

The new Medicare law provides seniors with immediate relief from high drug prices through the drug discount card and ensures that no low-income senior will pay more than five dollars for their prescriptions. It also takes steps to ensure that Medicare is available for the children and grandchildren of today's seniors.

- Americans are able to access Health Savings Accounts (HSAs) and put aside money for medical expenses. These innovative tax-preferred savings accounts give consumers more choice and control over their health care finances and decisions.
- To provide a framework for increased financial security, Republicans approved legislation to give workers more choice, information and access when it comes to their pensions.
- ➤ Social Security is one of our nation's most important programs, providing essential income security for families when a worker retires, becomes disabled, or dies. Republicans took steps to strengthen Social Security, while protecting it from waste, fraud and abuse.

Reforming Welfare, Promoting Work, Protecting Children

In 1996, Congress transformed the nation's failed welfare system into a work-based program that moved millions off welfare, into jobs and out of poverty.

- ➤ Welfare reform is a huge success work is up, caseloads have been cut in half, and child poverty is down significantly exactly the opposite of what opponents said would occur. The 2003 House-passed welfare reform bill (H.R. 4) promotes more work, less dependence, and further reductions in poverty. It also provides up to \$4 billion more for child care during the next five years so more low-income parents can go to work knowing their children are safe.
- ➤ In the wake of the 2001 recession and September 11 attacks, Republicans designed a program that provided special help to eight million long-term unemployed workers. At the same time, we gave states \$8 billion in flexible federal funds to help unemployed people go back to work, while keeping unemployment taxes down in 30 states, according to the U.S. General Accounting Office.
- ➤ Republicans have passed laws providing more services to keep troubled families together and promote more adoptions, like the Promoting Safe and Stable Families Amendments of 2001 and the Adoption Promotion Act of 2003.

- The House has twice passed *The Energy Tax Policy Act Conference Report* in 2003 and 2004. Most recently, on April 21, 2005, the House passed the Energy Policy Act of 2005.
