# WHAT SENATE & HOUSE REPUBLICANS HAVE SAID ABOUT BIPARTISAN CHILDREN'S HEALTH INSURANCE BILL

## **Senate Republicans**

#### Sen. Charles Grassley (R-Iowa)

"[This bill] breaks the legislative impasse and should have strong support from both Democrats and Republicans. The bill will enable the Children's Health Insurance Program to help cover millions more low-income children." [Joint press release, 9/21/07]

#### Sen. Orrin Hatch (R-Iowa)

"I have been fighting for legislation that will not only continue the CHIP program, but also cover more low-income kids who are eligible for CHIP. Today, we are unveiling our bipartisan compromise that accomplishes those two very important goals. Our proposal is an honest compromise which improves a program that works for America's low-income children." [Joint press release, 9/21/07]

#### Sen. Pat Roberts (R-Kan.)

"The Administration is threatening to veto this bill because of 'excessive spending' and their belief that this bill is a step toward federalization of health care. I am not for excessive spending and strongly oppose the federalization of health care. And if the Administration's concerns with this bill were accurate, I would support a veto. But, bluntly put, they are not." [Los Angeles Times, 9/28/07]

### Sen. Gordon Smith (R-Ore.)

"While some have alleged we are expanding the program, that rhetoric could not be further from the truth. We are not expanding the program; we are simply putting our money where our mouths have been. ... We are also not expanding government-run health care. SCHIP is a program that is delivered by private insurance companies. It is a program that requires families to pay premiums and copayments based on their income levels. It is for these reasons that SCHIP will garner strong, bipartisan support." [Cong. Record, 9/27/07]

## Sen. Olympia Snowe (R-Me.)

"SCHIP has truly been a saving grace for millions of families across America who otherwise could not afford to pay for their children's health care. I'm pleased that members of both the House and Senate, both Republican and Democrat, have come together in good faith to reach an agreement for the benefit of hard-working families in need.... I would strongly encourage the President to reconsider his short-sighted veto threat and work hand-in-hand with Congress to extend health insurance to countless, deserving children." [Cong. #### Sen. Lisa Murkowski (R-Alaska)

# **House Republicans**

### Rep. Ray LaHood (R-Ill.)

"This is a good bipartisan compromise to help the millions of uninsured children in our country. Whatever financial strains a family may endure, it should have no impact on the type and quality of care their child receives for health-related matters. #### Rep. Jim Ramstad (R-Minn.)

"We have a moral obligation to cover all our children so every child in America can grow up healthy. It's the right thing to do; it's also the cost-effective thing to do...That's why I strongly support extending and expanding SCHIP. I also hope we can work together to provide greater access to private insurance coverage for America's children and other uninsured Americans...There is no better investment than to invest in the health and well-being of America's children." #### **Rep. Vito Fossella (R-NY)**

"The SCHIP program has been a huge success in providing coverage to millions of uninsured, low-income children...It has played a key role in ensuring that children receive proper care and has helped put millions of young Americans on the path to a healthier lifestyle. While two-thirds of uninsured children are currently eligible for coverage through CHIP or Medicaid, many continue to go without the care they need because they have not joined the program. This legislation will benefit society as a whole benefits because taxpayers save when children receive proper preventative care and learn of medical conditions sooner. ### Rep. Phil English (R-Pa.)

# Rep. Mike Ferguson (R-NJ)

The bill recognizes New Jersey's high cost of living and makes certain that health coverage is provided to children in low- and moderate-income families who do not have employer-provided health insurance." ## Rep. Ralph Regula (R-Ohio)

The program has proven extremely successful in covering many children who had fallen through the cracks and providing them with quality preventive and acute healthcare. ## **Rep. Thomas Petri (R-Wisc.)**
