## SECTION I: FIREFIGHTING TRAINING, EQUIPMENT & EDUCATION

## **INTRODUCTION**

The following section has been compiled to provide information about training, equipment and educational opportunities for fire departments in the 11<sup>th</sup> Congressional District of Pennsylvania. As you might expect, the grant programs outlined in this section all operate under their own respective guidelines. Therefore, you should spend some time reviewing the specific eligibility requirements and limitations to determine their applicability to your situation. Congressman Kanjorski's office can assist you if you have any specific questions about any of the programs included in this section.

## U.S. FIRE ADMINISTRATION (USFA)

## Assistance to Firefighters Grant (AFG) Program

The purpose of the Assistance to Firefighters Grant (AFG) Program is to award one-year grants directly to fire departments and nonaffiliated emergency medical services (EMS) organizations of a State to enhance their abilities with respect to fire and fire-related hazards. The program's primary goal is to provide assistance to meet fire departments' and nonaffiliated EMS organizations' firefighting and emergency response needs. This program seeks to support organizations that lack the tools and resources necessary to protect the health and safety of the public and their emergency response personnel with respect to fire and all other hazards they may face.

USFA has established grant categories for eligible fire departments and emergency management organizations for this grant program. Each department can apply for grants in one of each category. Within each category, a department can apply for any number of eligible activities. The categories and eligible activities are as follows:

## **Fire Operations and Firefighter Safety**

The five different fundable activities that are included in this program area are listed below. All fire department activities must be applied for under the Fire Department Operations and Safety program area, including fire-based EMS training or equipment. Equipment requests must meet all mandatory regulatory requirements, as well as any national and/or DHS/FEMA-adopted standards, in order to be eligible for purchase with grant funds. Equipment/technology requests should have the goal of solving interoperability or compatibility programs.

Each of the below program areas has its own priority. Applications that focus on each of the programs priority are more likely to receive funding.

- Firefighter Training: Examples of training activities include, but are not limited to: Firefighter I and II certifications; First Responder EMS; drive/operator; fire officer; HAZMAT response; alternative fuel firefighting; incident command; supervision and safety; Chemical, Biological, Radiological, Nuclear, and Explosive (CBRNE) awareness, performance, planning and management; or train-the trainer courses in any of these areas. Applications focused on national or State certification training, including train-the-trainer initiatives, will receive a higher competitive rating.
- Firefighting Equipment: Funds are available to equipment to enhance the safety or effectiveness of firefighting, rescue, and fire-based EMS functions. Grants are also available for equipment necessary for response to CBRNE incidents. Priority will be given to fire departments to purchase firefighting equipment (including rescue, EMS, and CBRNE) that supports a department's existing mission or that replaces used or obsolete firefighting equipment. Second priority will be to fund departments seeking to expand their functional capabilities within their existing mission areas or to appropriately equip themselves to meet a new risk. Furthermore, the purchase of equipment that brings the department into compliance with nationally recommended standards (such as NFPA) or statutory compliance will receive the highest consideration. The purchase of equipment that brings a department into voluntary compliance with OSHA standards will also receive a high competitive rating but secondary to equipment that leads to a department's statutory compliance.
- Firefighter Personal Protective Equipment (PPE): Funds are available to acquire primarily OSHA-required PPE for firefighting personnel. Applications that request funding to replace equipment, the age and condition of the PPE that is to be replaced will be the primary consideration with the replacement of older or worn-out equipment receiving higher consideration than requests for replacement of newer equipment. For Self Contained Breathing Apparatus' (SCBA),

applications will only be considered for replacing old, inoperable SCBA and/or upgrading older SCBAs to new standard within a region if proper justification was provided. Specifically, applications will not be considered for replacement of SCBA that is compliant to the 1997 Edition of NFPA 1981 nor the 2002 Edition of NFPA 1981.

- Firefighter Wellness and Fitness: Fire department wellness/fitness activities must offer periodic health screenings, entry physical examination, and immunizations. Applicants for grants in this activity must currently offer, or plan to use grants to provide all three benefits in order to receive consideration for funding for any other initiatives under this activity. Higher competitive ratings will be given to applicants who lack wellness/fitness programs.
- Modifications to Fire Stations and Facilities: AFG grants may be used to modify fire stations and other facilities to protect the health and safety of firefighting personnel. Activities involving modifications to facilities are subject to all applicable environmental and historic preservation requirements. Grant funds may not be used for new construction. FEMA will NOT fund any requests for modifications other than the initiatives listed below:
  - o Sprinkler systems
  - o Smoke & Fire alarm notification systems
  - o Vehicle exhaust evacuation systems
  - Vehicle mounted exhaust filtration systems
  - o Air improvement systems
  - o Emergency power generators

The highest priority has been assigned to sprinkler systems, exhaust evacuation systems, and fire/smoke alarm systems. Grant funds are to be used only to retrofit existing structures that do not have the eligible safety features or to upgrade facilities whose features are outdated. Older structures will receive the highest consideration.

## Firefighting Vehicles

AFG provides grants for new firefighting vehicles, used fire apparatus originally designed for firefighting, or refurbished apparatus originally designed for firefighting. Applicants who serve rural communities are limited to one vehicle per application. (If a rural applicant submits an application requesting more than one vehicle, the application will be deemed ineligible.) Funds may also be used to refurbish a vehicle the department currently owns, but only if it is a vehicle originally designed for firefighting. New vehicles purchased with AFG funds must be compliant with NFPA 1091 or 1906 standards. Used apparatus must be compliant with NFPA 1901 or 1906 standards for the year the vehicle was manufactured. Refurbished apparatus must meet NFPA 1912 standards.

The following table lists the funding priorities for this program area by each type of community.

While writing your department's narrative, you should include if your department meets any of the following criteria to receive higher consideration for funding.

- Seeking to replace or refurbish unsafe vehicles rather than seeking to replace vehicles with safety features.
- Wanting to replace vehicles that have been converted for use as firefighting vehicles, but were not originally designed for firefighting
- Fire departments that own fewer firefighting vehicles like the type requested relative to other departments serving similar types of communities
- Departments with fewer vehicles of a given type than other departments that service comparable call volumes
- Departments possessing an aged fleet of vehicles
- Departments that have formal automatic aid agreements with neighboring departments
- If applicant has a comprehensive driver training program (Applicants without a comprehensive driver training program who will not implement appropriate driver training in conjunction with their AFG award or through other resources will NOT be considered for a vehicle award

## **Emergency Medical Services (EMS) Operations and Safety**

AFG funding priorities differ for fire departments and nonaffiliated EMS organizations. Equipment requested under AFG must meet all mandatory regulatory

requirements, as well as any national and/or DHS/FEMA-adopted stands in order to be eligible for purchase with grant funds. The Responder Knowledge Base (RKB), which can be accessed by visiting <a href="http://www.rkb.mipt.org/">http://www.rkb.mipt.org/</a>, includes relevant information on first responder standards and allows guest users to ask any questions they may have regarding applicable standards.

AFG grants may be used to enhance emergency medical services provided by nonaffiliated EMS organizations. FEMA will give a higher level of considerations to organizations with significant levels of incidents and to organizations that protect large populations relative to other applicants, regardless of the type of community served. Equipment/technology requests should have the goal of solving interoperability or compatibility programs. Therefore, applicants should describe in their narrative sections how the purchase of equipment would comply with standards and/or facilitate solving interoperability or compatibility problems.

The five different activities that are available for funding are as follows:

- **EMS** Training: Examples of training activities include, but are not limited to, fire responder, BLS, ALS, Paramedic, HAZMAT Operations, or Rescue Operations. Because training is a prerequisite to the effective use of EMS equipment, organizations whose requests are more focused on training activities will receive higher competitive rating than organizations whose requests are more focused on equipment. A higher competitive rating will be given for projects planning to upgrade services to ALS level of response. Furthermore, organizations that are seeking to elevate their response level from EMT-B to EMT-I will receive the highest priority and organizations that are seeking to elevate their response level from EMT-I to Emergency Medical Technician-Paramedic (EMT-P) will receive a high priority. Second priority will be given to elevate emergency responders' capabilities from first responder to a BLS level of response (i.e. EMT-B). Due to the time and cost, upgrading an organization's response level from EMT – B and EMT-P is a lower priority. Organizations seeking training in medical services will receive higher priority than organizations in rescue or HAZMAT operations. Organizations that are seeking to train a high percentage of their active first responders will receive additional consideration when applying under the Training Activity.
- EMS Equipment Acquisition: Because training is a prerequisite to the effective use of EMS equipment, organizations whose requests are more focused on training activities will receive a higher competitive rating than organizations whose requests are more focused on equipment. Applicants must demonstrate that users of equipment purchased with the grant either are, or will be, sufficiently trained to use the equipment. Organizations that request training to the ALS level of response, along with basic support equipment will receive a higher priority. Requests seeking assistance to purchase equipment to support BLS level of response are a secondary priority. Organizations seeking equipment for rescue or HAZMAT operations will receive lower consideration than

organizations seeking equipment used to provide medical services. Organizations upgrading their equipment for existing services will receive the highest consideration. Organizations taking on "new risks" (when an organization is forced to address risks that have materialized in the organization's area of responsibility i.e. a new chemical plant) will be considered a secondary priority. Organizations taking on a "new mission" (when an organization expands into an area not previously offered) will receive a lower priority. Organizations that are replacing used or obsolete equipment will receive lower consideration compared to organizations that are upgrading their equipment for existing services. Finally, equipment that will bring an organization into compliance with State or Federal regulations will receive higher consideration than equipment that has no statutory basis.

- EMS Personal Protective Equipment: AFG allows grant funds to be used to acquire PPE for active EMS first responder personnel, particularly PPE required by OSHA. Applicants who are not, or will not be, sufficiently trained to use the equipment requested under this activity will not be eligible for funding. AFG will prioritize funding for organizations needing to purchase PPE for the first time. FEMA will give very high consideration to organizations replacing obsolete or substandard equipment. In these cases, the condition of the equipment to be replaced will be factored into the score, with a higher priority given to replacing equipment that is old, damaged, torn, or contaminated over equipment that is worn but usable. In addition, FEMA will give a high competitive rating to EMS organizations with a large percentage of active staff without compliant EMS PPE. FEMA will give a high competitive rating to organizations that want to purchase enough PPE to bring their compliance to 100 percent.
- EMS Wellness and Fitness: Applicants for this grant must currently offer or plant to use grant funds for all three of these benefits: periodic health screenings, entry-level physical examinations, and immunizations. Highest consideration will be given to candidate physical agility evaluations. FEMA will afford higher competitive ratings to applicants lacking wellness/fitness programs over applicants who already employ a wellness/fitness program. Finally, FEMA will give higher competitive ratings to organizations whose wellness/fitness programs mandate participation and are open to al personnel.
- Modifications to EMS Stations and Facilities: Eligible modifications under this provision include only installation of the following: sprinkler system, smoke and fire alarm notification system, vehicle exhaust evacuation system, vehicle mounted exhaust filtration system, air improvement system, or emergency power generators. The highest priority has been assigned to sprinkler systems, exhaust evacuation systems, and fire smoke alarms. Grant funds are to be used only to retrofit existing structures that are outdated or do not have eligible safety features. Older structures built post 2003 will be given highest priority.

## **EMS Vehicle Acquistion**

AFG grants may be used to acquire new, used or refurbished EMS vehicles or to refurbish a vehicle the organization currently owns. Highest priority will be given to ambulances or transport units to support EMS functions. Vehicle grantee cannot use AFG funding as a substitute for their usual vehicle replacement budge, this grant is used to supplement not replace funding. Highest consideration will be given to vehicles converted to EMS vehicles but were not designed to be EMS vehicles or to replace vehicles without seatbelts. Priority will be given to organizations with few vehicles of a certain type or outdated vehicles. Organizations with a formal aid agreement will be given higher consideration. Applicants must have an established comprehensive driver training program. Grantee must upon receiving funds remove the unsafe vehicle from the organization.

The Department of the Interior receives an appropriated budget each year for a rural fire assistance (RFA) grant program. The maximum award is \$20,000. This funding will enhance the fire protection capabilities of rural and volunteer fire departments through training, equipment purchases, and fire prevention work on a cost-shared basis. The DOI assistance program targets rural and volunteer fire departments that routinely help fight fire on or near DOI lands. Under this legislation, the Pennsylvania State Fire Commissioner is the official charged with meeting the diverse training, operational, and informational needs of the Commonwealth's fire and emergency service community. The Commissioner, who is appointed by the Governor, oversees the development and operation of Pennsylvania's emergency service training program, the Volunteer Loan Assistance Program (VLAP) that provides low-interest loans to volunteer fire and emergency services organizations, and the state's fire safety education program. In addition, the Commissioner is responsible for the development of a comprehensive fire incident reporting system.

## Volunteer Fire Company, Volunteer Ambulance Service Grant

Grants to eligible Volunteer Fire Companies will be contingent on their agreeing to participate in and report information using the Pennsylvania Fire Information Reporting System (PennFIRS). These Volunteer Fire Company grant awards will be

calculated using a basic award of the first \$7,000.00 of the applicants grant request, plus an additional award representing all or a portion of the remainder of their request which will be determined by applying an award factor based on bonus points as described in the program guidelines. Volunteer Fire Company grants to individual volunteer fire companies shall not exceed \$15,000.00.

## Pennsylvania State Fire Academy (PSFA)

The Pennsylvania State Fire Academy provides comprehensive resident and weekend programs for firefighters, rescue personnel, arson investigators, hazardous materials teams, and other emergency responders. Through the use of high quality instructors, the Academy is able to develop, select, and conduct educationally-valid and technically up-to-date courses addressing the professional development needs of all participants in the fire service and emergency response community, while at the same time providing a means of professional certification through the National Board on Fire Service Professional Qualifications. In addition, the Academy offers both resident programs, whereas students report to the state facility, and also an Academy on the Road program, where the course travels to local communities.

Section 10(b)3 of the Cooperative Forestry Assistance Act of 1978, as amended by the Forest Stewardship Act of 1990, authorizes and directs the Secretary of

Agriculture to provide financial, technical and other assistance to state foresters or other appropriate officials in cooperative efforts to organize, train and equip local forces in rural areas or communities under 10,000 population to prevent, control and suppress fires which threaten human life, livestock, wildlife, crops, pastures, orchards, woodlands, farmsteads, or other improvements in rural areas. ## Section II:

## FIREFIGHTING HIRING, RECRUITMENT & RETENTION

## INTRODUCTION

In recognition of the fact that only limited funding is available to assist fire departments in the hiring, recruitment and retention of firefighters, Congressman Kanjorski voted in favor of the legislation that created the Staffing for Adequate Fire and Emergency Response (SAFER) program. The SAFER Act authorizes grants to career, volunteer and combination departments. The program not only provides funding to hire firefighting personnel, it also provides funds to volunteer departments to strengthen the recruitment and retention of volunteers. Grants are to be awarded on the basis of need through a competitive, peer-reviewed process modeled after the Assistance to Firefighters grant program. The goal is for SAFER grantees to enhance their ability to attain 24-hour staffing, thereby ensuring that their communities have adequate protection from fire and fire-related hazards. The following pages go into greater detail on this program.

## STAFFING FOR ADEQUATE FIRE & EMERGENCY RESPONSE (SAFER)

The SAFER grants have two activities: 1) <u>hiring of firefighters</u> and 2) <u>recruitment and</u> retention of volunteer firefighters.

The Hiring of Firefighters Activity portion of this program involves a five-year grant to assist fire departments pay a portion of the salaries of newly hired firefighters. These newly hired positions must be in addition to authorized and funded active firefighter positions. Grantees that fail to maintain this level of staffing risk losing all or a portion of their grant. Volunteer, combination, and non-profit career fire departments are all eligible to apply for assistance in hiring new firefighters. These grants require the awardee to match an increasing proportion of the salary over a four-year period; in the fifth year of the grant, the awardee must absorb the entire cost of any positions awarded as a result of the grant. It is my understanding that the federal grants will pay 90-, 80-, 50- and 30-percent of the employee's salary in the first four years, with the municipality or fire department agreeing to fully fund the employee from the fifth year on.

The Recruitment and Retention of Volunteer Firefighters Activity grant provides assistance to awardees for periods of up to four years. The purpose of these grants is to assist with the recruitment and retention of volunteer firefighters. Volunteer departments, combination departments and local or statewide organizations that represent the interests of volunteer firefighters are eligible to apply for assistance under this activity. Below are a few quick details that you should keep in mind.

#### **Eligibility**

Your type of organization affects your eligibility for funding. All volunteer and combination fire departments may apply for either or both of the two grant program activities. Volunteer firefighter interest organizations are eligible for funding only in

the Recruitment and Retention of Volunteer Firefighters Activity. Career fire departments are eligible for funding only in the Hiring of Firefighters Activity.

The counties that compose the 11<sup>th</sup> Congressional District of Pennsylvania are divided into two Counter Terrorism Task Force: the *Northeast PA Emergency Response Group* and the *East Central PA Counter Terrorism Task Force*. The vast majority of Homeland Security grant money is for both training and equipment funding to organizations that supply first providers, primarily police and fire departments as well as medical professionals.
