Project Description: The project involves the renovation of a 67,000 square foot warehouse, providing a central location where children and adults can receive high quality care regardless of their income or insurance status.

The renovation includes Pediatrics, Adult Medicine, Obstetrics and Gynecology, Dental, Medical Records, Women Infant and Children (WIC), Social Services Programs Department and Administration as well as subtenant space for a full service laboratory and pharmacy. Incubator-style business lease space for community health related tenants will also be incorporated as subtenants. The project will create 67 medical and dental exam rooms; three rooms per medical provider and two operatories per dentist, which will improve operational efficiency and effectiveness.

Hamilton's existing buildings are old, and costly to repair. Additionally, the demand for services has surpassed existing building capacity. This building project will significantly increase access and availability of medical, dental and social services for Dauphin County's uninsured and underinsured low income population and create approximately 50 jobs in addition to sustaining an existing 140 positions currently supported by Hamilton. In addition, this project is expected to be the economic catalyst to attracting more businesses to this area of the City of Harrisburg.

Project Description: National Standards for patient care beds set forth by the Joint Commission on Accreditation of Health Care Organizations (JCAHO) mandate specific patient care beds. St. Luke's Miners Memorial Hospital is located in a Federal Medically Underserved Area and operates with only a 0.7% operating margin.

residents of Schuylkill County, Pennsylvania. This project will develop new community partnerships and use existing one to address the needs of this population. The result will be increased access to quality low-cost primary and preventative health care. The program also promotes healthy lifestyles, continuing education, and employment among this population. The success of this project can be demonstrated through a decrease in the use of emergency rooms as a source of primary health care, a decrease in employee absences, an increase in public and private health coverage, and improved health outcomes of the uninsured and underserved residents of this rural county and of the community-at-large.

Project Description: Purchase of a comprehensive clinical and patient management technology solution for the emergency department. The solution will help to increase clinical quality, throughput, operational efficiency and patient satisfaction. The technology solution will be certified for meaningful use or will be integrated with certified electronic medical records (EMRs). This solution includes hardware and software that will connect and integrate the emergency department with internal departments as well as clinics within the community, ensuring coordination of care among providers. The solution will enhance the emergency department's ability to identify special needs and resource issues related to the uninsured and underinsured populations. It will increase effectiveness of healthcare resources.

Project Description: The New Man Community Development Corporation's Workforce Development Capacity Expansion program has two objectives: (1) to improve the job training and entrepreneurial skills of Pennsylvania's unemployed and dislocated workers recovering from addiction; and (2) to build New Man's capacity to provide ongoing workforce training for individuals recovering from addiction. Federal funds would be used to support three on-the-job training programs: an mechanic shop, a landscaping service, and a warehousing supply-chain classroom. New Man would hire three new trainers who will teach New Man's students the skills necessary to find employment in the mechanic, landscaping, and warehousing industries. In addition to the trade skills development element of the program, each trainer will teach students about the business administration elements of running a small business, equipping them with the information they need to develop the knowledge, skills and abilities sought after in the new economy. Each program will also operate as a business, with the students serving as employees. The program is designed to become self-sufficient through program revenue generated by students working for paying clients.

Project Description: **Passport to Manhood** promotes and teaches responsibility to Club boys ages 11-14. It consists of 14 sessions, each of which concentrates on a specific aspect on manhood through highly interactive activities. Each Club participant receives his own "passport" to underscore the notion that he is on a personal journey of maturation and growth. Passport to Manhood represents a targeted effort to engage young boys in discussions and activities that reinforce positive behavior. **Smart Girls** in an outgrowth of the popular and effective SMART Moves program, SMART girls is a health, fitness, prevention/education and self-esteem enhancement program for girls ages 10-15. The program is designed to encourage healthy attitudes and lifestyles that will enable early adolescent girls to develop to their full potential.

Project Description: Federal funding is requested specifically for the second and third phases of the project. In these phases, the project team will develop eight learning modules based on the knowledge foundation established in phase one. These modules will include materials to be used in a traditional classroom instructional environment as well as specific assignments to be completed as field study.

These modules will be delivered via the Internet, and students will have the ability to share their observations from field study assignments with other students via the curriculum website. Each learning module will be developed in a sequence of specific steps including assessments in support of a formative evaluation plan involving structured pilot testing and extensive feedback from students and teachers prior to final distribution via the Internet. The implementation plan also includes an assessment period to provide data for a final summative evaluation to establish the effectiveness of the modules in achieving the two major goals for the curriculum.

In summary, federal funding is requested for the second and third years of a three year project. Year One of the project has been funded by the Pennsylvania Department of Conservation and Natural Resources. In Year Two of the project, federal funding will support the development of five learning modules and related formative evaluation activities. In Year Three of the project, federal funding will support the development of the final three modules and related formative evaluation activities with additional emphasis on a summative evaluation and the final revision of the modules before they are released to the public.
