**AMENDMENT TO H. R. 4437, AS REPORTED  
OFFERED BY MR. GOODLATTE OF VIRGINIA AND  
MS. HERSETH OF SOUTH DAKOTA**

At the end of the bill, add the following new title:

1           **TITLE IX—SECURITY AND**  
2           **FAIRNESS ENHANCEMENT**

3   **SEC. 901. SHORT TITLE.**

4           This title may be cited as—

5                   (1) the “Security and Fairness Enhancement  
6           for America Act of 2005”; or

7                   (2) the “SAFE for America Act”.

8   **SEC. 902. ELIMINATION OF DIVERSITY IMMIGRANT PRO-**  
9                   **GRAM.**

10           (a) **WORLDWIDE LEVEL OF DIVERSITY IMMI-**  
11 **GRANTS.**—Section 201 of the Immigration and Nation-  
12 ality Act (8 U.S.C. 1151) is amended—

13                   (1) in subsection (a)—

14                           (A) by inserting “and” at the end of para-  
15                   graph (1);

16                           (B) by striking “; and” at the end of para-  
17                   graph (2) and inserting a period; and

18                           (C) by striking paragraph (3); and

19                   (2) by striking subsection (e).



1 (b) ALLOCATION OF DIVERSITY IMMIGRANT VISAS.—

2 Section 203 of such Act (8 U.S.C. 1153) is amended—

3 (1) by striking subsection (c);

4 (2) in subsection (d), by striking “(a), (b), or  
5 (c),” and inserting “(a) or (b),”;

6 (3) in subsection (e), by striking paragraph (2)  
7 and redesignating paragraph (3) as paragraph (2);

8 (4) in subsection (f), by striking “(a), (b), or  
9 (c)” and inserting “(a) or (b)”; and

10 (5) in subsection (g), by striking “(a), (b), and  
11 (c)” and inserting “(a) and (b)”.

12 (c) PROCEDURE FOR GRANTING IMMIGRANT STA-  
13 TUS.—Section 204 of such Act (8 U.S.C. 1154) is  
14 amended—

15 (1) by striking subsection (a)(1)(I); and

16 (2) in subsection (e), by striking “(a), (b), or  
17 (c)” and inserting “(a) or (b)”.

18 (d) EFFECTIVE DATE.—The amendments made by  
19 this section shall take effect on October 1, 2006.
