


Why We Need It



Economic Downturn is Worsening: National Job Loss




The Majority of States are in Recession



Moody's assessment is based on four key indicators used by the National Bureau of Economic Research: employment, industrial production, retail sales adjusted for inflation, and income to develop a composite indicator. A state is considered to be in recession if that indicator falls for six months or longer. An area is "at risk" if it has declined for three months.


National Household Net Worth Is Steeply Declining





Unprecedented Accountability

- Presidential Website
 - How funds spent
 - Announcements of opportunities & requirements
 - Identity of Program Managers
- Public Notification of Funding
 - Description & purpose of investment funded
 - Total cost
 - Why it should be funded with federal \$
 - Certification of full vetting and appropriate use of taxpayer \$ by Governors, Mayors, others

Renewable, Efficient American Energy

- Doubling Renewable Energy Production
 - \$54 Billion transform energy distribution & production, power fuel-efficient vehicles & improve energy efficiency
 - \$20 Billion tax cuts and credits for renewable energy research and production
- Creating Green Jobs
 - 500,000 new American jobs
- \$8 Billion Renewable Energy Loan Guarantees



Braley Amendment

- Added during E&C Markup Thursday
- Creates new category for Renewable Energy Loan Guarantees
- Adds "leading edge biofuel projects" as third option for funding
- Biofuels portion: \$500 million
- must produce transportation fuels that substantially reduce life-cycle greenhouse gas emissions



Science and Technology



- \$16 Billion Science and Technology Funding
 - \$10 Billion Science Facilities and Research
 - Solve energy and climate challenges
 - Find cures and treatments for diseases
 - \$6 Billion Expand Broadband Internet Access
 - Provide fast Internet service to rural and other unserved and underserved areas
 - Allow rural businesses to link up to global economy



Infrastructure Repairs and Improvements



- \$90 Billion –(Create 1.8 million American Jobs)
 - \$30 billion highway & bridge construction
 - \$4.5 billion Corps of Engineers for environmental restoration, flood protection, and navigation infrastructure
 - \$1.1 billion Amtrak and passenger rail, including \$300 million for Intercity Passenger Rail Grant Fund
 - \$6 billion Clean Water State Revolving Fund loans to help communities upgrade wastewater treatment systems
 - \$6 billion buses and equipment to increase public transit and improve intermodal facilities

Education for the 21st Century

- \$141.6 Billion Improve Classrooms & School Libraries; Help Children Compete in Global Economy
 - □ \$57.2 Million Iowa's 1st District
 - \$15.6 Billion increase maximum Pell Grant by \$500
 - \$300 Million improve teacher quality and address teacher shortages
 - \$20 Billion school modernization and technology

Tax Cuts and Incentives

- Tax Relief 95% of American Workers
 - Refundable tax credit: \$500 per worker/\$1,000 per couple
 - First step towards permanent Middle Class tax relief
 - Child Tax Credit & Earned Income Tax Credit expansion
- Business Tax Incentives
 - Tax credit hiring veterans and youth
 - Extending Small Business Expensing for greater capital investments and equipment purchases

Lowering Healthcare Costs and Modernizing Healthcare System

- \$3 Billion prevention and wellness initiative
- \$87 Billion temporary Medicaid increase, to provide lowa with at least a 4.9% increase in federal Medicaid
- \$600 Million training health care professionals through National Health Service Corps
- \$1.5 Billion Community Health Clinics
- \$39 Billion coverage for those who lose their jobs
- \$20 Billion Health Information Technology
 - Cut Red Tape
 - Prevent Medical Mistakes
 - Create New Jobs



Helping Workers Hurt by Economy

- \$43 billion increased unemployment benefits and job training
- \$39 billion healthcare coverage for the unemployed through COBRA and short-term Medicaid eligibility
- \$20 billion increase food stamp benefits by over 13% to defray rising food costs



Administration of the Stimulus

Methods used to distribute economic stimulus funds:

- Block & Formula Grants Iowa State Departments and Agencies
- Community Development Block Grants (CDBG)
- Existing Federal Programs Direct Increases in Appropriations Amounts
- Direct Allocations to Federal Agencies (Departments of Agriculture, Transportation, Energy, Education, Commerce, Health and Human Services, Etc.)
