BRMC-YC, which includes Internal Medicine, Family Practice and Pediatrics, treated 9,494 individual patients in FY 2009. The current system, purchased in 1995, is only capable of providing basic film x-rays for chest, arms, legs and feet. Because of the age of this equipment, the quality of the image is not as clear and the equipment is subject to increasing downtime for repairs. Furthermore, the weight limit for the current table is 350 pounds and we have a number of patients exceeding that weight limit. The new system supports up to 650 pounds. Maintaining quality medical facilities in the rural counties of Western North Carolina helps protect the public safety, health and well being of the citizens of these communities, and promoting effective preventative treatments ultimately saves taxpayer dollars by easing the burden on emergency rooms and Medicare.

# Cherokee County Wastewater Project

Taxpayer investment in this infrastructure is needed now to avoid significantly greater expenditures in the future.

# City of Hendersonville Emergency Operations Center

The communities of Western North Carolina require significant upgrades and repairs to water and sewer lines to ensure public health and safety as well as providing infrastructure for further industrial investments and job creation. Taxpayer investment in this infrastructure is needed now to avoid significantly greater expenditures in the future.

#### Clay County Mobile Data Project

This regional approach will also reduce redundancy in training facility construction by allowing neighboring counties to use the facilities, thus saving additional taxpayer funds.

## Building for Jackson County Neighbors in Need

The health department is located in a former mental health facility and is inadequate to serve the volume of patients seeking care. There are only two examination rooms greatly limiting clinic flow and increasing the waiting time for patients. There is no space for interviewing/ counseling patients or providing patient work-ups prior to seeing the provider. Maintaining quality medical facilities in the rural counties of Western North Carolina helps protect the public safety, health and well being of the citizens of these communities, and promoting effective preventative treatments ultimately saves taxpayer dollars by easing the burden on emergency rooms and Medicare.

# Madison County Law Enforcement Center

Construction of a new Fire Fighting Team Support Facility is vital to providing emergency support for local theater operations and training for one NCNG Engineer Fire Fighting Team. The NCNG has two fire fighting teams in the central/eastern part of the state. One team has been reassigned to Murphy to provide fire fighting support to the western part of NC and to provide more realistic training opportunities by being in the mountains and in close proximity to civilian fire fighting training centers, enhancing unit readiness. Proper training facilities capable of meeting training, administrative, and storage requirements do not currently exist at Murphy or surrounding environs.

The Rural Center's 2003 extensive assessment of state and local resources for entrepreneurship development identified significant barriers for the self-employed or small business owner, including a lack of capital, sense of isolation, difficulties in accessing technical assistance and technology, and workforce development. With federal support, the NC Rural Center will increase its outreach into rural communities by utilizing the Homegrown Jobs Center. The Center will seek to

aggressively engage rural economically distressed communities through a series of outreach meetings designed to increase local capacity for economic development.

# Explanation of the request:

The Rural Center Water and Wastewater System Efficiency Program provides technical and financial assistance for rural towns to conduct water audits, undertake a leak detection program to identify sources of major water loss under the ground in either the water or sewer system, and access resources to repair such leaks. The program will reduce operating costs, conserve water, and/or prevent environmental contamination. The program also demonstrates that investments in existing systems will generate additional capacity, reduce the amount of unbilled water, and reduce expenses caused by inflow and infiltration in these systems, thus reducing the demand for federal and state program dollars (EPA, USDA, ARC, and EDA) to support more costly methods of system replacement. The communities of Western North Carolina require significant upgrades and repairs to water and sewer lines to ensure public health and safety as well as providing infrastructure for further industrial investments and job creation. Taxpayer investment in this infrastructure is needed now to avoid significantly greater expenditures in the future.

# North Carolina Rural Center Energy Efficiency Retrofit Initiative

### Explanation of the request:

The businesses will be required to achieve certain benchmarks. If achieved, the loan is forgiven. These efficiency upgrades will lower the annual operating costs for private manufacturers, encouraging them to expand or to locate in economically distressed rural areas of North Carolina. These retrofits will also lower the demand for energy generation in North Carolina, reducing the need for expensive investments in additional generation capacity.

The North Carolina State Highway Patrol is the largest law enforcement agency in the State of North Carolina. The agency employs 1,827 sworn "State Trooper" positions, with each Trooper having statewide enforcement jurisdiction. The state of North Carolina encompasses 48,000 square miles. In addition to its statewide law enforcement role, the State Patrol also serves as the lead agency for the implementation of North Carolina's Voice Interoperability Project for Emergency Responders (VIPER), a statewide, state of the art, Project 25 APCO-Compliant, 800-MHz multi-agency voice trunked radio system. This system is being developed as a single communications system that will allow all properly equipped federal, state, and local emergency responders to share a common communications platform for incident command, scene safety, and operational coordination. A regional approach to emergency services and law enforcement will significantly reduce taxpayer costs currently associated with travel costs for personnel training in distant and dispersed training facilities.
