FY2011 Military Construction Appropriation

and Authorization Requests

Aircraft Conversion; Army National Guard; Stewart International Airport, NY; \$3,500,000

Adequately sized and properly configured space is needed to support C-17 aircraft at the base. This funding would support construction and upgrading of facilities to accommodate the unique needs of C-17 aircraft which are expected to arrive at the base in 2011. This project would benefit the taxpayer by enabling Stewart International Airport to accommodate C-17 aircraft, increasing training opportunities and efficiency.

Alert Holding Area; Army; Fort Drum, NY; \$6,700,000

This funding would support construction of an Alert Holding Area (AHA) to include a concrete marshalling area and a cargo inspection facility with weigh-in-motion scales. Supporting facilities would include electronic services, site lighting, communications, utilities relocation, fire protection, hardstand, fencing, guard building, and other improvements. This project would benefit the taxpayer by providing adequate facilities for the inspection of equipment for outloading by air and ground that is critical to Fort Drum's mission to provide safe and efficient deployment from the fort.

Ammunition Supply Point Improvements; Army; Fort Drum, NY; \$7,600,000

This funding would support an upgrade of the Ammunition Supply Point (ASP) including construction of four new earth-covered magazines and a new administration facility. This project would benefit the taxpayer by supporting training and deployment of the 10th Mountain Division and other units that train at Fort Drum.

C-130 Flightline Operations Facility; Air Force Reserve; Niagara Falls ARS, NY; \$9,500,000

This funding would support construction of a replacement C-130 flightline operations facility to support the joint 914th Airlift Wing and 107th Airlift Wing Association. Facility would include squadron operations, life support and survival equipment, base operations, airfield management, weather station, command post, and garage. This project would benefit the taxpayer by giving the two organizations the most efficient use of space and efficiency of operations.

Chapel Addition and Alteration; Army; Fort Drum, NY; \$6,900,000

This funding would support construction of an addition to, and remodeling of, an existing chapel at Fort Drum that would bring the chapel up to Army standards. The facility would include a worship center, activity center, offices, classrooms, kitchen and other activity spaces. This project would benefit the taxpayer by bringing the existing facility up to Army standards and providing adequate facilities for religious worship at Fort Drum.

Construct Railhead Loading Area; Army; Fort Drum, NY; \$7,500,000

This funding would support construction of a new railhead loading area with concrete ramps, paved container side loading area, and a rail operations storage building. This project would benefit the taxpayer by enhancing Fort Drum's Power Projection Platform capabilities through enhancements to both safety and operational efficiency during deployment operations.

Rochester Fuel Facility; Army National Guard; New York Army National Guard Army Aviation Flight Facility #2, Rochester, NY; \$1,166,000

This funding would be used to construct an aircraft fuel storage and vehicle fueling facility on public land licensed to the New York Army National Guard in Rochester, NY. This would relieve the Army National Guard aircraft and units from depending upon civilian sources for meeting fuel requirements. This project would benefit the taxpayer by releasing the Army National Guard aircraft units from depending upon civilian sources for providing all fuel to support missions.
