

FISCAL 2011 TRANSPORTATION, HOUSING AND URBAN DEVELOPMENT AND RELATED AGENCIES APPROPRIATIONS REQUESTS

Through the Transportation, Housing and Urban Development and Related Agencies Appropriations Act, Congress allocates funding for the U.S. Department of Transportation and the U.S. Department of Housing and Urban Development, and related agencies each year. In developing this legislation, Senators and Representatives are afforded the opportunity to seek funding for key local transportation projects and economic development initiatives. Further, the communities along the I-81 Corridor demand that safety improvements and environmental protection efforts progress at levels commensurate to growth in freight traffic. Thus, the Federal funds used for this project are an investment in the nation's economic growth, traveling safety, and environmental protection efforts.

With its age and constant usage, there is a continual struggle to keep the equipment operating with minimal malfunctions, down time, delays and customer inconvenience. These fareboxes are utilized on SEPTA's bus and trackless trolley fleet that serve 120 routes in Bucks, Chester, Delaware, and Montgomery Counties and the City of Philadelphia. Project proponents expect to create 475 jobs through this project.

Purpose: In conjunction with the Center City District's proposed renovation of Dilworth Plaza, SEPTA will perform an early action phase of its City Hall Station Renovation project, including elevators, signage, inter-station corridors, waterproofing, and ventilation improvements. The City Hall Station provides access to the Broad Street Subway, Market-Frankford Subway Elevated, 13 Regional Rail lines, and several SEPTA bus routes in close proximity. Reconstructing the entrances and connections at this station will create a major portal to Philadelphia's multi-modal transit system.

This rail startup commuter service will provide service to Monroe, Wayne, Lackawanna and Pike Counties regions of Pennsylvania which include the fastest growing counties in Pennsylvania in terms of population growth. Over 20,000 Pennsylvania residents commute to jobs in New Jersey and New York City every day and this project will provide an alternative means of commuter service. If awarded, funding should be directed to the Pennsylvania Department of Transportation.

workforce of over 2,000. Carlisle Tire and Wheel has announced its intent to relocate to Tennessee by fall 2010 due in part to a lucrative incentive package. Similarly, IAC closed its Carlisle plant in December 2008 and moved its manufacturing operations to various facilities throughout the U.S. and Mexico. Both plants are now being marketed and their former workforces displaced. If funds are obtained, the proposed project will return these sites to productive uses. Job creation, tax revenue generation, and social and environmental responsibility are key objectives. Once acquired and remediation addressed, the sites will be transformed into multifaceted uses. The project will be an economic and environmental model for Brownfield revitalization. Uses such as new and small enterprise, light industrial, tourism anchors and health/business centers are proposed.
