## **OUR FUTURE LEADERS: ALEJANDRO JIMENEZ-JARAMILLO & ALLAN CHENG**



### FROM DREAM TO REALITY? COMMISSION BEGINS STUDY OF NATIONAL **MUSEUM OF THE AMERICAN LATINO**

If you want to know what it means to be an American, the best way to find out is by visiting the outstanding museums that line the National Mall in Washington, D.C. However, when you finish your visit to these institutions you won't walk away with a complete picture. The story of Latinos in America, which predates the founding of the first colonies, is largely absent from the mosaic portrayed in our national museums. That is why, six years ago, I introduced legislation to establish a commission to study the potential creation of a national museum of the American Latino. Signed into law last year by President Bush, the bill mandates the establishment of a bipartisan 23-member commission to explore and report back to Congress on the possibility of building such a museum focused on the vast contributions Latinos have made to our nation's history and culture. The commission is expected to submit its report within a year.







### **ECONOMIC RECOVERY MEANS JOBS FOR MAIN STREET**

American economy back from the brink, moving us from hit hardest by the recession with extended unemployment 741,000 job losses in January to 11,000 in November—the fewest since the recession began (see chart below, left). At the same time, America's economic output shifted from a steep 6.4 percent decline at the beginning of 2009 to 2.2 percent growth this fall (see chart below, right). That is the largest six month turnaround in 29 years. The nonpartisan Congressional Budget Office (CBO) estimates that the Recovery Act has created or saved up to 1.6 million jobs, with less than half of the money spent. Unfortunately, many working families are still struggling to overcome the longest and deepest economic downturn since the Great Depression. We must do more. On December 16, the House of Representatives passed the Jobs for Main Street Act to make targeted job-creating investments in America's infrastructure and small businesses. The Housepassed bill invests \$48 billion to put people back to work rebuilding roads and bridges, modernizing public buildings, and improving clean water infrastructure. It also includes \$27 billion to save or create approximately 250,000 education jobs over the next two years and put 5,000 law enforcement officers on the beat(see top-right chart for investment proportions). The

Some economists credit the Recovery Act for bringing the bill also includes economy-boosting emergency aid for those benefits and help with health insurance costs. The recent increase in weekly unemployment claims to 480,000 makes it clear that our work is not finished.







### RECOVERY ACT SAVING AND CREATING JOBS HERE IN LOS ANGELES

Recovery Act has already created and saved approximately 2.000 jobs in Los Angeles (Recovery Accountability and Transparency Board, 2009). Many of those jobs include teachers in our public schools, nurses in our neighborhood health clinics, and workers repairing our

Since it was signed into law in February, the more than \$400,000 in Los Angeles to train workers in the green energy and construction jobs of the future—from home weatherization to building the next generation of energy efficient and sustainable buildings.
