A BILL

To amend the Reclamation Projects Authorization and Adjustment Act of 1992 to require the Secretary of the Interior, acting through the Bureau of Reclamation, to take actions to improve environmental conditions in the vicinity of the Leadville Mine Drainage Tunnel in Lake County, Colorado, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Leadville Mine Drain-
- 5 age Tunnel Act of 2010".

1 SEC. 2. TUNNEL MAINTENANCE.

- 2 Section 705 of the Reclamation Projects Authoriza-
- 3 tion and Adjustment Act of 1992 (Public Law 102–575;
- 4 106 Stat. 4656) is amended to read as follows:
- 5 "SEC. 705. TUNNEL MAINTENANCE.
- 6 "The Secretary shall take such steps to repair and
- 7 maintain the structural integrity of the Leadville Mine
- 8 Drainage Tunnel as may be necessary to maintain the
- 9 Leadville Mine Drainage Tunnel in safe condition and to
- 10 preclude uncontrolled release of water.".
- 11 SEC. 3. WATER QUALITY RESTORATION.
- 12 (a) IN GENERAL.—Section 708(a) of the Reclamation

- 15 (1) by striking "(a) The Secretary" and insert-

- 16 inserting "this section and sections 705 and 707".
- 17 (c) Conforming Amendment.—The table of con-
- 18 tents of title VII of the Reclamation Projects Authoriza-
- 19 tion and Adjustment Act of 1992 (Public Law 102-575;
- 20 106 Stat. 4601) is amended by striking the item relating
- 21 to section 705 and inserting the following:

"Sec. 705. Tunnel maintenance.".
