Dear Congressman Waxman:

This is a follow-up to my letter of May 10, 2006, regarding your request for information on the Capital Asset Realignment for Enhanced Services (CARES) process for the West Los Angeles Department of Veterans Affairs (VA) Healthcare Center campus.

The Veterans Health Administration has prepared the enclosed fact sheet and two CD ROMs which provide the documentation that you and Chairman Tom Davis requested.

I wish to bring to your specific attention information contained in this material related to your requests #13 through #16 concerning environmental issues, and in particular, any possible radioactive medical wastes beneath or near the location of the Brentwood School's athletic fields. VA's response clearly identifies a number of independent consultants and Federal and state reports that reviewed this issue. The conclusion of all these reports is that there were no radioactive materials on the site. Unfortunately, a draft CARES report that should not have been released to your office contained an erroneous statement that indicated radioactive materials may be present on site. That draft CARES report was placed on your Web site. The contractor subsequently reviewed the reports and removed the reference from the final report to VA that will be released when I have made my decision regarding which options are to be studied in CARES Phase 2.

A recent Los Angeles Times article resurfaced this same issue. In order to alleviate the public's apprehension and validate that there is not any danger, the VA Greater Los Angeles Healthcare System has engaged the environmental consulting firm, Millennium Consulting Associates, to provide a new environmental assessment to check for radioactive waste contained in the soil in this area of the West Los Angeles VA campus. However, to avoid any further misunderstanding regarding this issue, I am requesting that you remove the draft CARES report from your Web site and when it is available replace it with the corrected final report.

The information provided to you in response to your request may contain trade secrets or confidential commercial or financial information which would be exempt from disclosure under the Freedom of Information Act (FOIA), 5 U.S.C. 552(b)(4). The information contained in the awarded contract provided to you for use in your capacity as Ranking Member of the Oversight Committee, would be considered as such information (5 U.S.C. 552(b) (4)). Although FOIA does not apply to the documents once they are released by VA to the Oversight Committee, we caution against further disclosure of the contractors' proposal because of the sensitive nature of the information contained therein. Other documents provided are only authorized for release to the Committee in its oversight capacity and we ask that they not be shared with the general public.

As the CARES process moves from development into implementation, we will continue to honor VA's commitment to provide quality care to our Nation's veterans. VA's goal is to continue to provide West Los Angeles veterans with quality health care and access to specialty services in a cost effective manner, while maximizing any reuse of the current VA property.

Thank you for your continued interest in health care for our Nation's veterans. A similar reply has been sent to Chairman Davis.

Serving the Needs of Homeless Veterans

Request 12: The California Department of Veterans Affairs (CDVA) has reported that there are more veterans living within a 50-mile radius of the West Los Angles VA Medical Center than in 42 other states combined. A recent report issued by the Los Angeles Homeless Services Agency (LAHSA) found that of the 82,291 homeless people in Los Angeles County, 15,420 of them are homeless veterans. Given this overwhelming population of homeless veterans in Los Angeles County, please provide my office with the VA's plan to address homelessness in the Los Angeles area during the CARES process.

Response: VA is providing you with an overview of the history and current scope of services for homeless veterans at the VA Greater Los Angeles Healthcare System (GLA) through its Comprehensive Homeless Center. This document provides: a history of VA homeless programs at GLA; the number of veterans affected by homelessness and where they are; the causes of veteran homelessness; what is being done to help veterans who are or will become homeless; how VA is working with the public and private sector to help West Los Angeles veterans; the impact VA is making on veteran homelessness at GLA; and what is in store for the future.

Request 13: Please provide all documents given to PwC, Enterprise Solutions, MicroTech and any other contractor or vendor regarding environmental issues and hazards at the West Los Angeles VA Medical Center.

Response: The Brentwood school project documents were provided to PwC regarding environmental issues at the West Los Angeles VA Medical Center. The initial study (Brentwood School Project, Environmental Documents, 1981-1983) identified a number of environmental parameters that would be affected by the proposed project. Minor (non-significant) environmental parameters that were briefly discussed included: earth/soil: air quality; hydrology; plant life; light and glare; land use; utilities and cultural/archaeological resources. The environmental impact report for the proposed Barrington Recreation Center addition focused primarily on four major environmental parameters: noise; recreation; traffic circulation and parking; and radiological health and safety.

The purpose of the Soil Investigation Report by Locus, (November 21, 2000) was to provide additional characterization for a portion of the GLAHS property known as the Brentwood School Lease Area (Lease Area). An Environment Assessment (EA) was also prepared by Locus, under contract to Coastal, on behalf of the GLAHS on October 23, 2000. The EA concluded that no significant impacts to the human environment were present at the Lease Area.

Request 14: Please provide all environmental studies and research conducted on behalf of the VA or its contractors regarding the West Los Angeles VA Medical Center since the issuance of the August 2005 Stage I Summary Report Appendix.

Response: No environmental studies for West Los Angeles have been conducted since August 2005.

Request 15: What is contained in the 10 underground storage tanks at the West Los Angeles VA Medical Center and when were they last tested for leaks?

Response: Eight of the underground storage tanks contain diesel fuel for emergency generators, one contains unleaded gasoline and one contains waste motor oil. All tanks meet current California and Federal Environmental Protection Agency (EPA) standards and all have leak monitoring systems. The tanks are inspected monthly by an outside contractor and inspection records are maintained in the Medical Center's Safety Office. The last inspection was conducted in May 2006.

Request 16: Who removed the excavated radioactive medical waste that was beneath or near the site where the Brentwood School has constructed athletic fields?

Response: There were never any radioactive materials buried at the leased Brentwood School nor were there any removed. During the construction of the Brentwood athletic complex in 2000, the area was fully excavated to remove unsuitable soil such as demolition debris, trees, inert medical debris and incinerator ash (Reference Locus Technologies Environmental Assessment and Soils Report, dated 2000). The biomedical waste burial site is south of the Brentwood school lease, in a secure fenced area where during the 1950s and 1960s low level radioactive isotopes were discarded. This area is considered a "closed site" and has been deemed by the U.S. Nuclear Regulatory Commission, EPA and the Los Angeles County Department of Health Services as no hazard to the general public and is inspected quarterly by the Los Angeles County Solid Waste Division.

Request 17: Is VA aware of any other hazardous material dumps on any part of the current or former VA West Los Angeles property? If so, please describe in detail, including type of material dumped and remediation or removal date.

Response: There are no hazardous waste dumps at the VA West Los Angeles except for the closed site that is described in item #16. The VA does not dump any solid or hazardous waste on the site. All waste is removed from the site by outside contractors on a routine basis.

Request 18: Has the VA conducted remediation on any of the buildings at the West Los Angeles VA Medical Center found to have Lead-Based Paint (LBP), Asbestos Containing Materials (ACM) or mold? If so, when and how was the remediation conducted and which buildings were remediated?

Response: Several documents on asbestos and lead abatement activities for the West Los Angeles campus are provided. The medical waste storage area is a centralized accumulation located in the back of the main hospital. All radioactive materials are received through Building #345, where they are checked in and issued through Radiation Safety. Each user has to be certified to use any radioactive materials. In the Research complex there is one secure building where all spent radioactive materials are accumulated before the outside vendor removes them from the site in compliance with state and federal regulations. There are no methane gas areas at West Los Angeles and mold is remediated on a case-by-case basis.

Request 19: Please provide any and all engineering reports and environmental reports regarding Radioactive Material Storage, LBP, ACM, Underground Storage Tanks, Medical Waste Disposal Areas, Solid Waste Disposal, and Mold and Methane Gas at the West Los Angeles VA Medical Center.

Response: Several reports on asbestos inspections are provided in response to this request. The June 1996 inspection for asbestos containing materials consisted of a walk-through of the accessible areas, visual observation for the presence of potential asbestos containing materials (ACM) and sampling of presumed asbestos containing materials and conditional reassessment of the known ACMS. Flooring, calling, baseboard, thermal system insulations on ducts/aircells, and composite roofing and penetration mastic were formerly sampled and tested.

In November of 2002, Environmental Engineering Inc. performed a re-inspection of the site structures to identify, assess, and sample suspect ACM and to recommend, if

necessary, appropriate response actions upon the findings of the survey. The survey consisted of a walk-through of the accessible areas, visual observation for the presence of potential ACM and sampling of presumed asbestos containing materials and conditional reassessment of the known ACMS.
