





















































Methodology:

This survey was conducted through US Mail, with survey forms being mailed directly to 147,066 voting constituent households. The survey was mailed on March 10, 2010 and responses were accepted through April 23, resulting in 14,124 responses. It is important to note that this survey was not designed to function as a public opinion poll, but rather as an accurate depiction of the policy preferences and concerns of voting constituents in the Fourth Congressional District. As such, methodological measures were not employed to offset word and question ordering effects, nor have results been weighted to reflect regional population or demographic quotas. Nonetheless, received responses were generally in line with the geographic distribution of the district's population, with a deviation of approximately five percent or less.
