Navajo Heritage Center, Inc., Farmington, NM, \$500,000

This project will include new classroom space, a small library, conference room, games/activity area and a new kitchen and cafeteria.

#### **KiMo Theater Renovations**

KiMo Theater/Keshet Dance Company, Albuquerque, NM, \$1,000,000

Plan, design, renovate, construct, equip and furnish the historic KiMo Theatre, adjacent building and parking garage in downtown Albuquerque, Bernalillo County to include rehearsal studios, scene shop, stage renovations, ADA accessibility and parking structure improvements in order to provide professional dance, theater, music & film presentations, educational programs & statewide services reaching special needs populations including at-risk youth, incarcerated youth, homeless youth and community members of all ages with physical disabilities.

## **Las Cruces Downtown Revitalization**

City of Las Cruces, NM, \$1,000,000

To progress with redevelopment activities within the core of the City to help spur economic activity and revitalize the blighted downtown center.

# Mesilla Valley Community of Hope Emergency Shelter Space Renovation/Rehabilitation

City of Las Cruces, NM, \$953,410

The former emergency shelter space been unused since 2006 and requires repairs, renovations, and upgrades.

#### **Mind Research Facility Expansion**

The Mind Research Network for Neurodiagnostic Discovery, Albuquerque, NM, \$2,000,000

For the construction of facility modifications necessitated by research expansion. Funding will provide MRN with critical space needed to further expand core facilities and to meet anticipated short- and long-term research program goals.

# National Museum of Nuclear Science & History Expansion & Updates

National Museum of Nuclear Science & History, Albuquerque, NM, \$750,000 This is the only museum designated by Congress regarding nuclear science, enacted 1991. Began construction of a new building in April 2009, however it remains incomplete due to funding.

## **Navajo Code Talkers Museum and Veterans Center**

Navajo Code Talkers Foundation, Window Rock, AZ, \$19,538,400

Construction of a museum and veterans center dedicated to the Navajo Code Talkers and their service during WWII. The educational and job opportunities afforded to the area through the work of the museum are in the taxpayers' interest.

## **New Mexico Centennial Project**

Department of Cultural Affairs, State of New Mexico, \$5,000,000

Seek programming and operating funds which will help support numerous activities such as special volunteer/service initiatives, cultural and historical activities, and promotion of the unique historical and cultural resources of New Mexico.

### New Mexico's Veteran's Museum

New Mexico Department of Cultural Affairs, Las Cruces, NM, \$1,600,000 For construction of the New Mexico Veteran's Museum. Will provide a tribute to the service of past and current veterans while telling the story of the state's important and unique history in the U.S. military.

## Palace of the Governors Renovation & Expansion

State of New Mexico, Santa Fe, NM, \$1,500,000

To complete financing for renovation and preservation of the Palace of the Governors, the National Historic Landmark property that is the historic site on the grounds of the New Mexico History Museum (NMHM) campus in Santa Fe, NM.

# **Regional Judicial Complex**

McKinley County, Gallup, NM, \$750,000

This project would allow for the construction of a joint Municipal/Magistrate Judicial Building to improve security, provide modern technology in the office and court room, create workable courtroom spaces, and create common areas that can regionalize services and create better economies-of-scale in terms of cost.

# Roadrunner Food Bank Warehouse

Roadrunner Food Bank, Albuquerque, NM, \$300,000

Providing a permanent warehouse to Roadrunner food collection agency for homeless and poverty stricken families in New Mexico.

## San Juan College Regional Fire Sciences Training Center

San Juan College, Farmington, NM, \$2,000,000

Funds will support Phase I – including the training center strategic business plan, a fire tower and water tank for the College property being leased through the Bureau of Land Management.

## San Miguel Courthouse/Public Works Facility Project

San Miguel County, Las Vegas, NM, \$544,253

Renovation of the County Courthouse to include energy efficiency upgrades and an irrigation/cistern system and a public works facility designed to utilize solar systems for the daily energy supply.

## Santa Fe Innovation Park

The Santa Fe Innovation Park, Medanales, NM, \$3,500,000

Creation of a technology park site and construction and furnishing thereof. The park would be a portal to the New Mexico Computing Applications Center, a supercomputer

funded by the state.

# Taos County Administrative/Judicial Complex Equipment and Software

County of Taos, Taos, NM, \$2,200,000

To furnish, acquire, and equip the complex Taos County Administrative/Judicial Complex, and to purchase inmate management software for the adult/juvenile detention facility.

# Taos Pueblo Village Restoration & Preservation

Taos Pueblo, Taos, NM, \$1,738,055

Funds from this Appropriation will be used to reverse deterioration that is threatening the very existence of the millennium-old structures in its traditional village.

# **Tatum Municipal Building**

City of Tatum, NM, \$135,000

To provide for a renovation to change a old roof inside the building from flat to pitched. It would be of the best interest to the public as the roofing is unsafe and outdated.

## **Tijeras Maintenance Department**

Village of Tijeras, Tijeras, NM, \$600,000

Facility will allow for the storage of the city's salt spreading vehicle, utility truck, backhoe and tractor, and provide space for repair of equipment and components that support the water system.

YWCA Middle Rio Grande, Albuquerque, NM, \$450,000

To achieve optimal staffing levels and provide a comprehensive transitional living program for up to 20 at-risk women veterans and their children, a program which does not currently exist in New Mexico for this specific population.

#### **Veterans War Memorial**

City of Carlsbad, NM, \$200,000

For construction of a Veterans Memorial which will possibly provide for a statue.

#### **Walker Aviation Museum**

Walker Aviation Museum Foundation, Roswell, New Mexico, \$380,000

To build a museum dedicated to Walker Air Force Base. The museum will promote and support the educational, cultural, scientific, and professional development of Chaves County and SE New Mexico including developing support and interest in the historical aspects of Walker Air Force Base along with its past relationship to the City of Roswell.

# Instituto de Agua y Cultura

University of New Mexico-Taos, NM, \$600,000

The requested funding will be used by the University of New Mexico-Taos branch, located in Taos, New Mexico, to complete construction of the shared spaces for the water institute, "Instituto de Agua y Cultura", and the Southwest Research Center.
