As you know, entry to a service academy comes at the end of a very competitive process. Approximately 10-12% of applicants are accepted. There are a variety of alternative programs and avenues to pursue in the event you do not receive a nomination, cannot attend the academy of your choice, or will be attending college for a year or two while re-applying for an academy nomination. Please consider us as a resource in the event any of these circumstances occur.

Please adhere to the application process instructions closely as incomplete applications will not be considered. Deadlines will be adhered to absolutely! Your application, letters of reference and all correspondence should be sent as a package to:

**NOMINATION PROCEDURES FOR CLASS 2015
ENTERING ACADEMIES IN JUNE 2011**

For all Colorado applicants for military service academies

From the office of

United States Senator Michael Bennet

The purpose of the nomination procedure is to present the service academies with qualified candidates from every area of the country. My nomination functions as a recommendation to the academies and it is my responsibility to nominate the best qualified young people in the state of Colorado. In order to do this, I ask that each candidate submit certain credentials which will be evaluated. **It is the candidate's responsibility to insure that the information is submitted by the deadline.** Interviews will be conducted by interview committees in October and November. Applicants will be notified by mid-December.

IN ORDER TO BE CONSIDERED FOR A NOMINATION, YOU MUST TAKE THE FOLLOWING STEPS:

- 1) Complete and submit, **by mail, not fax***, the enclosed Application Form. It is important that the form be filled out neatly and be completed **in ink or typed, and unaltered**.
- 2) Write a Personal Letter (business style) to Senator Bennet explaining your reasons for seeking a nomination to an academy. Remember to sign the letter.
- 3) At least one of three Recommendation Cover Forms and Recommendation Letters must be completed by a teacher, principal, or counselor. Other recommendations may be completed by someone who knows you well, but not a family member.
- 4) Attach an official copy of your High School Transcript (if available). **GPA and CLASS RANK are desired (if your school ranks)**.
- 5) Attach a copy of your ACT and/or SAT scores, if not already included in your transcript.
- 6) Include a photograph, 3 x 4 or wallet size.

APPLICATION ITEMS SHOULD BE SENT AS A COMPLETED PACKAGE. INCOMPLETE APPLICATIONS OR APPLICATIONS RECEIVED AFTER OCTOBER 8, 2010 WILL NOT BE CONSIDERED.

***Faxed applications will be accepted only from students living outside the United States.**

1. Completed **Application Form**.
2. **Personal letter** (business style, signed) to Senator Bennet, indicating your desire to attend a service academy.
3. **Official Academic Transcript** sent by the academic institution. Please ensure that the transcript indicates **current GPA and Class Rank**. If an official transcript is not available, send what you have as a placeholder. When the official transcript becomes available have it sent. If your school does not rank students, please contact the Nominations Coordinator at 303-455-7600.
4. **Copies of ACT and/or SAT test scores** if not included on the transcript.
5. **Three letters of Recommendation**. One must be from a teacher, principal, or counselor. Recommendations from family members will not be accepted.
6. **One photograph**, (3X4 or wallet size).
