BERKS COUNTY



Berks County has benefitted significantly from the Recovery Act. As a direct result, over 182,000 constituents received a tax cut. In addition, Berks County has received over \$202 million in funding for education, transportation, and infrastructure and other projects.

Education

The Recovery Act is providing much-needed federal funding for local school districts. School districts are using these funds for a variety of purposes, including special education, educational technology, and basic education needs. These funds have unequivocally prevented the elimination of teaching positions and have helped stabilize education budgets throughout the Commonwealth. Specific awards in Berks County include:

Transportation and Infrastructure

The Recovery Act is helping Pennsylvania revitalize its transportation infrastructure through highway resurfacing and bridge rehabilitation projects. It is also providing funding for key infrastructure projects designed to improve water quality. Specific awards in Berks County include:

- ➤ 182,730 residents of Berks County have enjoyed federal tax relief as a result of the Recovery Act
- ➤ 20,500 jobless adults will receive a boost in unemployment compensation
- ➤ 18,800 unemployed persons qualify for more help purchasing health insurance
- > 70,175 low income children and adults will continue to have access to health care through Medical Assistance
- ➤ 54,062 children and adults will receive more help through the Supplemental Nutrition Assistance Program (Food Stamps)

Other Recovery Act funding for Berks County

- ➤ \$1,001,240 to the Community Services Recovery & Reinvestment Project. The project will establish a one-stop community resource center to provide non-traditional and easy access to community social services systems and resources for those persons and families who have recently experienced job loss and a reduction in income with little or no knowledge of, or experience accessing, services that are available in the local community.
- > \$791,000 to Reading, in the form of an Energy Efficiency and Conservation block grant
- ➤ \$2,973,200 to Berks County, in the form of an Energy Efficiency and Conservation block grant
- > \$725,297 to Berks County, in the form of a Community Development
