


LYCOMING COUNTY	
	<p>Lycoming County has benefitted significantly from the Recovery Act. As a direct result, over 52,000 constituents received a tax cut. In addition, Lycoming County has received over \$45 million in funding for education, transportation, and infrastructure and other projects.</p>

Education	<p>The Recovery Act is providing much-needed federal funding for local school districts. School districts are using these funds for a variety of purposes, including special education, educational technology, and basic education needs. These funds have unequivocally prevented the elimination of teaching positions and have helped stabilize education budgets throughout the Commonwealth. Specific awards in Lycoming County include:</p> <ul style="list-style-type: none"> ➤ \$1,297,165 to the East Lycoming School District ➤ \$2,403,403 to the Jersey Shore Area School District ➤ \$717,634 to the Loyalsock Township School District ➤ \$902,800 to the Montgomery Area School District ➤ \$1,197,813 to the Montoursville Area School District ➤ \$847,857 to the Muncy School District ➤ \$1,085,842 to the South Williamsport Area School District ➤ \$5,493,252 to the Williamsport Area School District

Transportation and Infrastructure	<p>The Recovery Act is helping Pennsylvania revitalize its transportation infrastructure through highway resurfacing and bridge rehabilitation projects. It is also providing funding for key infrastructure projects designed to improve water quality. Specific awards in Lycoming County include:</p> <ul style="list-style-type: none"> ➤ \$722,800 for rehabilitation State Route 2085 over Muncy Creek ➤ \$603,200 for rehabilitation of US Route 220 ➤ \$761,752 for rehabilitation of State Route 2048 ➤ \$1,368,174 to resurface US Route 220 in Penn Township ➤ \$552,511 to resurface State Route 2014 in Montoursville Borough ➤ \$1,498,867 to mill and resurface State Route 3028 in Jersey Shore Borough and Porter Township ➤ \$904,287 for bridge preservation of 8 bridges in Lycoming County ➤ \$7,036,543 for resurfacing of the Lock Haven Bypass ➤ \$792,461 to micro-resurface PA14 ➤ \$2,141,302 to resurface US Router 15 in Lewis, Old Lycoming, and Lycoming Townships

Here is how Lycoming County residents are benefiting:</p> <ul style="list-style-type: none"> ➤ 52,037 residents of Lycoming County have enjoyed federal tax relief as a result of the Recovery Act ➤ 7,200 jobless adults will receive a boost in unemployment compensation ➤ 5,800 unemployed persons qualify for more help purchasing health insurance ➤ 20,315 low income children and adults will continue to have access to health care through Medical Assistance ➤ 14,594 children and adults will receive more help through the Supplemental Nutrition Assistance Program (Food Stamps)
