### PHILADELPHIA COUNTY



Philadelphia County has benefitted significantly from the Recovery Act. As a direct result, over 506,000 constituents received a tax cut. In addition, Philadelphia County has received over \$1.9 billion in funding for education, transportation, and infrastructure and other projects.

#### Education

The Recovery Act is providing much-needed federal funding for local school districts. School districts are using these funds for a variety of purposes, including special education, educational technology, and basic education needs. These funds have unequivocally prevented the elimination of teaching positions and have helped stabilize education budgets throughout the Commonwealth. # Transportation and Infrastructure

The Recovery Act is helping Pennsylvania revitalize its transportation infrastructure through highway resurfacing and bridge rehabilitation projects. It is also providing funding for key infrastructure projects designed to improve water quality. Specific awards in Philadelphia County include:
