The fact that 95% of consumers are outside of the U.S., but only 1% of our companies are involved in exporting is a challenge for the growth of small business.

However, I believe that in times of economic downturn, America can use this as an opportunity to roll up its sleeves and create a win-win situation. We can create jobs here at home by providing avenues in which small business can export goods and services abroad, thereby increasing the income of the respective countries. The more counties spend on our services, the more our small business profit. This will help to reverse the current economic downturn our nation faces today.

I am confident that small businesses have the ability to effectively compete on a local, national, and global market if we provide them access to the resources they need. As a Member of the House Small Business committee, I will continue to fight on behalf of small business so that they can succeed in the global economy.

### **National Cyber Security Awareness Month 2009**

Americans rely on information technology in every aspect of our lives – from managing businesses to social networking. As innovation spurs increased access and demand for the internet and information technologies, cyber warfare and cyber crime are increasing in sophistication and frequency. That is why; I introduced H. Res. 797, which supports the goals and ideals of National Cyber Security Awareness Month 2009. I am committed to working with Federal agencies, national organizations, businesses, and educational institutions to encourage the development and implementation of existing and future cyber security standards, practices, and technologies that enhance our nation's security.

I will also be hosting a series of roundtables and events this month, designed to examine key policy considerations and to educate Members of Congress and their staffs on ways to protect their own computers.

### Legislative Spotlight

As our nation seeks to move towards economic recovery, we must ensure that our veteran, minority, and women-owned small business have access to the tools they need to succeed.

The construction industry often serves as an entry point for emerging small businesses, including those undertaken by minorities, women and veterans.

These enterprises may be contractors, specialty trade contractors, suppliers, fabricators, vendors or the myriad other businesses serving the needs of the construction industry.

The construction industry provides a variety of rewarding careers. However, construction is a challenging and competitive business environment that demands that business owners have specialized knowledge and skill sets.

That is why on Thursday, October 8, 2009, I introduced H.R.3771, *The Veteran, Minority and Women-Owned Construction Business Mentorship and Grant Assistance Act of 2009*." This bill will provide unprecedented support to minority, women and veteran-owned small construction businesses through mentorship and grant assistance programs.

Specifically, the proposed legislation amends the Small Business Investment Act of 1958 to establish grant programs for minority, veteran, and women-owned small business construction companies. The grant program would provide funds to hire legal, accounting, and business consultants for the purpose of creating the internal business systems that are essential for success. Funds would also be made available to local groups and schools to bolster technical assistance to these firms.

This legislation is supported by 18 Members of Congress and 11 veterans, small business and construction trade organizations.

The federal government must continue to play a unique role in assisting small businesses; they are the backbone of our nation's economy.
