

**Project Description:** Construct a standard Combat Pistol/Military Police Qualification Course (CP/MPQC). Primary facilities include the range, range operations and control area, Range Control Tower, Operations/Storage Building, Latrine, Bleacher Enclosure, Classroom Building, Ammunition Breakdown Building, Covered Mess, and building information systems. Supporting facilities include electric service and information systems.
