Game-changing strategies for reducing this casualty rate rests on several means for reducing fossil fuel dependence, thus reducing the need for fuel convoys. These include widespread and aggressive conservation techniques; the use of renewable resources, in particular, solar and wind energy within the theater... Beyond sustainability and economics, this study demonstrates that the development and use of alternative energy can be a direct cause for reductions in wartime casualties"
