The competitive project prepares high school students for postsecondary studies that lead to careers in the fields of math and science.



"This invaluable funding will provide more of our lowincome, first-generation students the support they need to finish high school and achieve success in college," said Hinojosa. "This grant will also impact our region's economic competitiveness because it will inspire more of our talented youth to pursue in-demand careers in math and science."

How do you keep your nonprofit financially stable when the economy has the jitters and donors have cold feet? Weathering a bad economy should not send your nonprofit skittering to the bunkers, but it should sharpen your focus and improve your efficiencies. Here are five suggestions to consider for the economic bad times.

portant to cut costs as to raise revenue. But don't cut costs in a way that will impair your organization's long-term health or ability to achieve its core mission. Take a look at what is working well and what isn't; what is essential to the mission and what isn't. Cut the extraneous, the unfocused, the inefficient.

5) Cut costs...sensibly - In tough times, it can be just as im-

- 1) <u>Don't Pull Back on Fundraising</u> Just as companies need to keep advertising during a downturn to keep their names before the public, nonprofits will gain nothing by retreating. Not only should you not retreat, you should become even more focused in your efforts. Look at your lists again, sharpen your case, get more personal, and cultivate within an inch of your life.
- 2) Let your donors know that those you help are in more need than ever - No matter how a donor may be hurt by an economic downturn, the disadvantaged are damaged far more and have less opportunity to recover.
- 3) Find the stories that will touch the hearts of your donors -Now, more than ever, search out the personal testimonies of your clients and let them speak to your donors in their own words. Don't sink into begging, but show the shared humanity between donors and those served.
- 4) Take the opportunity to lower fundraising costs For instance, eschew an expensive fundraising event and go directly to your donors for their help. Wrap a simple, low-cost mailing around the fact that you are lowering overhead by skipping the event, and ask for a direct gift that will put more services and money into your clients' lives. Do the same with your publications. Ask donors to help you devote more of their donor dollars to direct service.

6) Take a new look at projects you intended to raise money for - If the project is not "essential," perhaps it should be postponed. A new building project, while desirable, might not be the best project right now. Think, rather, about services that go on despite a recession or even intensify. Perhaps scholarships would be an easier thing for donors to support, or medical research in a significant health area. Books for children in under served areas and playgrounds in the inner city seem more worthwhile than an endowment fund in uncertain economic times. Don't worry about changing course. Let your donors know, and explain why. If your reasoning is good and heartfelt, your donors will come along with you. You will not only do more good, but keep donors engaged until better times come along.

Through this category the National Endowment for the Arts seeks to make the excellence and diversity of the arts widely available to the American public through nationally distributed television and radio programs. Grants are available to support the development, production, and national distribution of radio and television programs on the arts. Priority will be given to artistically excellent programs that have the potential to reach a significant national audience, regardless of the size or geographic location of the applicant organization. Only programs of artistic excellence and merit, in both the media production and the subject, will be funded. Projects may include high profile multi-part television and radio series, single documentaries, performance programs, or arts segments for use within an existing series. Programs may deal with any art form (e.g., visual arts, music, dance, literature, design, theater, musical theater, opera, film/video/audio art, folk & traditional arts). Programs targeted to children and youth are welcome. All phases of a project -- research and development, production, completion and distribution costs -- are eligible for support. We welcome proposals that include ancillary activities that are intended to increase public knowledge, understanding, and access to the arts. Such activities might include the use of related radio and television programming; interactive Web sites; DVDs or other digital applications; educational material; collaborations with arts organizations, educators, and other public outreach activities.

Eligible Applicants: Nonprofit, tax-exempt 501(c)(3), U.S. organizations; units of state or local government; or federally recognized tribal communities or tribes may apply.

American Heritage Preservation Grants

Institute of Museum and Library Science (IMLS)

Deadline: 09/15/2008

The purpose of the American Heritage Preservation Grants program is to raise awareness and fund preservation of treasures held in small and midsized museums, libraries and archives that convey the essential character and experience of the United States. These artifacts can be of diverse origin, but should have significance in the heritage of the community in which they are now held. Priority will be given to smaller institutions, but all libraries, archives, and museums that meet IMLS institutional eligibility criteria are eligible to apply. Grants will provide funds to preserve specific items, including works of art, rare books, scientific specimens and historical documents (photographs, maps, deeds, etc.) that are in need of conservation. These funds are not intended to fund a small portion of a larger project, but are aimed at completing a stand-alone conservation project. Applicants will build on completed conservation assessments of their collections, to ensure that the American Heritage Preservation Grants go towards projects that represent best practices in the field and underscore the importance of assessment planning (Conservation Assessment Program (CAP) grants, NEH Preservation Assistance grants (PAG) state grant programs, or other internal or external strategic assessments). All eligible institutions may apply for projects in the following areas: Treatment of library, museum and archival collections, Improvement of collections storage, Environmental improvement of collections.

Eligible Applicants: public or private libraries and museums, or a unit of state or local government or a private not-for-profit organization that has tax-exempt status under the Internal Revenue Code (see specifics on RFP).

Lego Systems Inc., the Americas (North America and Latin America) division of the Lego Group, a privately-held, family-owned firm based in Billund, Denmark, has announced the formation of the Lego Children's Fund, a nonprofit foundation established to support organizations and programs dedicated to inspiring and encouraging youth creativity, thereby improving their quality of life and preparing them for the future. The Lego Children's Fund was incorporated with an initial corporate contribution of \$1.2 million dollars. The National Geographic Society's Young Explorers Grants offer opportunities to individuals between the ages of 18 and 25 to pursue research, exploration, and conservation-related projects consistent with National Geographic's existing grant programs, including the Committee for Research and Exploration, the Expeditions Council, and the Conservation Trust. The Young Explorers Grants Program supports a variety of projects and an age-range of applicants generally not covered by other sources of funding. Applicants are not required to have advanced degrees. However, a record of prior experience in the fields of research, conservation, or exploration should be submitted as it pertains to the proposed project. Funding is not restricted to citizens of the United States, and foreign nationals are invited to apply. Researchers planning work in countries abroad should make great effort to include at least one local collaborator as part of their team. Young Explorers Grants vary in amount depending on the significance of the project, though most will range between \$2,000 and \$5,000 each. Because National Geographic Society funds often serve as complementary support, the program encourages applicants to seek additional funding from other sources.

The National Aeronautics and Space Administration Office of Education, in cooperation with NASA's Science Mission Directorate, solicits proposals for the NASA Global Climate Change Education project. The GCCE project is designed to improve the quality of global climate change and Earth system science education at the elementary, secondary, and undergraduate levels. Each funded proposal is expected to take advantage of NASA's unique contributions in climate science to enhance students' academic experiences and/or to improve educators' abilities to engage and stimulate their students. The GCCE project considers proposals in three funding categories. Proposals are invited in the following categories: efforts to improve K-12 teacher competency for global climate change education; efforts that strengthen the teaching and learning about global climate change within formal education systems; and/or efforts that provide opportunities for undergraduate students, pre-service teachers, and/or in-service teachers to actively engage in global climate change science research. Open Rivers Initiative

U.S. Department of Commerce (DOC), National Oceanic and Atmospheric Administration (NOAA)

The NOAA Open Rivers Initiative (ORI) provides funding to catalyze the implementation of locally-driven projects to remove dams and other river barriers, in order to benefit living marine and coastal resources, particularly diadromous fish.
