Zoe -

Yesterday, our Board approved the attached summary report on the County of Santa Clara's ARRA activities. This report provides information on the ARRA funds received by County departments, the status of County departments' grant applications for ARRA funds, and County jobs retained or created with ARRA funds. This letter highlights some of the information contained in the report.

The estimated overall ARRA benefit to the County is **\$159.8 million**. This amount is based on increases to formula funding, additional formula grant funds, and competitive grant awards that the County has received to date. Additionally, the State also received ARRA funds, and a portion of this money is being used to expand some State-administered grant programs that fund local agencies. The amount of the County's overall ARRA benefit will increase as County departments continue to pursue the expanded grant opportunities provided in ARRA.

ARRA funds have resulted in the County's ability to retain 79 and add 43.5 new County positions for a **total of 122.5 positions**. All of the retained positions are in the Santa Clara Valley Health and Hospital System. The new positions include 37 in the Social Services Agency, 5 in the Office of the Sheriff, and 1 in the Office of the Public Defender.

As we have previously expressed, our Board is extremely grateful for the financial assistance we have received through ARRA. Thank you again for your support of ARRA and the aid it is providing to the County.



SUBJECT: Report on American Recovery and Reinvestment Act of 2009 Funding and Activities for the Period of April 2009 to September 2009

RECOMMENDED ACTION

Accept report on the County of Santa Clara's funding and reporting activities related to the American Recovery and Reinvestment Act (ARRA) of 2009 for the period of April through September 2009.

FISCAL IMPLICATIONS

There is no impact to the County General Fund as a result of approving the recommended action.

CONTRACT HISTORY

None.

REASONS FOR RECOMMENDATION

On a quarterly basis, the Administration has reported on the status of the County's receipt of ARRA funding and our transparency and accountability activities. In addition, departments have sought, at various times, Board approval of ARRA competitive grant applications.

On October 10, 2009, all ARRA fund recipients were required to submit their first quarterly reports to the Federal Government for the period of April 1, 2009 through September 30, 2009. Following a thirty-day comment and revision period, the reports were finalized. This report provides information on the ARRA funds received by County departments, the status of County departments' grant applications for ARRA funds, and County jobs retained or created with ARRA funds.

Increase in Funding

ARRA provides direct funding to the County through time-limited formula funding increases, additional funds through one-time formula grants, and expanded grant opportunities. ARRA funding is generally provided through December 31, 2010, which is one quarter into Federal Fiscal Year 2011 and halfway into the County's Fiscal Year 2011. There are exceptions to this general principal, and some competitive grant programs will extend beyond this date. At this time, the estimated overall ARRA benefit to the County is **\$159.8 million**. This amount is based on increases to formula funding and additional formula grant funds, such as, Federal Medical Assistance Percentage (FMAP), Temporary Assistance for Needy Families (TANF) Emergency Contingency Fund (ECF), Title IV-E, Highway Infrastructure Investment Formula, Community Development Block Grant Formula, Homelessness Prevention and Rapid Re-Housing Program, and Justice Assistance Grant Formula.

The increase in the FMAP rate will provide the County with an additional **\$15,409,283** for the time period of July 1, 2009 through September 30, 2009. Both the Social Services Agency and Santa Clara Valley Health and Hospital Agency receive FMAP funds. The County's Fiscal Year 2010 Approved Budget includes the anticipated revenue from the FMAP increase.

Additional formula grants have provided the County with **\$5,629,197** in funds. The breakdown on these funds and corresponding programs is as follows:

Infrastructure Investment Formula (Roads)	\$3,800,000
Community Development Block Grant Formula	\$ 469,256
Homelessness Prevention and Rapid Re-Housing Program	\$ 717,484
Justice Assistance Grant Formula	\$ 642,457*

*The County administers the Justice Assistance Grant Formula funds for most of the law enforcement agencies in the county. As the administrator, the County received \$2,565,061. The \$642,457 amount is the County's share of the funds for its justice programs.

The Roads Department used the Infrastructure Investment Formula funds on pavement rehabilitation projects. The funds paid for the completion of the Montague Expressway Pavement Rehabilitation project as well as the County Unincorporated Roads project, which repaired portions of Moorpark Avenue, South Bascom Avenue, Tully Road, and White Road.

The Office of Affordable Housing (OAH) is the recipient of the Community Development Block Grant (CDBG) Formula and Homelessness Prevention and Rapid Re-Housing Program funds. The CDBG funds are being used to rehabilitate a dormitory at the Mariposa Lodge, a women's substance abuse treatment facility utilized by the Department of Drug and Alcohol Services. Following a Request for Proposals process, the Homelessness Prevention and Rapid Re-Housing Program funds were allocated to EHC LifeBuilders, Community Technology Alliances, and Sacred Heart Community Services Agency to assist people who have lost or who are at risk of losing their homes.

The County's share of Justice Assistance Grant (JAG) funds is supporting projects in the Office of the Sheriff, the Office of the Public Defender, and the Department of Correction. The Office of the Sheriff is using its funds to add a crime analyst position to its Cold Case/Crime Unit. The Office of the Public Defender is expanding its Expungement Program to all residents of the county with misdemeanor convictions by adding one and a half staff positions, a full-time Office Specialist position, and a half-time Attorney, to the program. The Department of Correction intends to use JAG funds to conduct an evaluation of current inmate programs to determine their effect on reducing recidivism.

ARRA Competitive Grants

County departments have also pursued and benefited from the expanded grant opportunities provided in ARRA. During this first reporting period, County departments submitted twelve grant applications to various Federal agencies. Three grant awards totaling \$1,398,739 have been approved, six were not approved, and three are still pending. The awarded grants include one for the Office of the Sheriff in the amount of \$782,866, which funds three management analyst positions over a two-year period to provide crime analysis, intelligence sharing, and coordination support to the office and other law enforcement agencies. The Santa Clara Valley Health and Hospital System received two grants totaling \$615,873 to expand health care services to homeless patients in the county. These funds will help manage the increased demand for health care services by homeless patients and to renovate some clinical suites at the Valley Health Center at Bascom.

State-Administered ARRA Grants

The State also received ARRA funds, and a portion of this money is being used to expand some State-administered grant programs that fund local agencies. As a result, the Office of the Sheriff and the District Attorney's Office both received additional grant funds from the California Emergency Management Agency (CalEMA). The Office of the Sheriff received a \$250,000 grant from the Sexual Assault Specialized Response Unit Program. These funds will add one Deputy Sheriff position to the department's Sexual Assault Investigation Unit and pay for enhanced victim services. The District Attorney's Office received \$60,770 from the Victim Witness Assistance Program - Victims of Crime Act

Grant and the Victim Witness Assistance Recovery Act – Violence Against Women Act Stimulus Grant. These funds will help pay the salary and benefits costs for Victim Advocate positions. The attached table provides information on all grant applications submitted by County departments.

Jobs Retained or Created

The County's receipt of ARRA funds has resulted in our ability to retain 79 and add 43.5 new County positions for a total of 122.5 positions. All of the *retained* positions are in the Santa Clara Valley Health and Hospital System. The *new* positions include 37 in the Social Services Agency, 5 in the Office of the Sheriff, and 1.5 in the Office of the Public Defender.

BACKGROUND

The American Recovery and Reinvestment Act of 2009 was signed by President Obama on February 17, 2009. The Act provides a variety of financial mechanisms, including tax credits and cuts, infrastructure funding, and benefit protections intended to create jobs and stimulate the economy. ARRA provides funding until December 31, 2010, or into Fiscal Year 2011.

On January 27, 2009, the Administration presented a report to the Board of Supervisors that provided information on the opportunities to seek Federal funding from ARRA. The Administration also provided the Board with status reports on April 21, 2009 and September 11, 2009.
