

AMENDMENT TO H.R. 3200
OFFERED BY MR. BUYER OF INDIANA

In section 59B(d)(2) of the Internal Revenue Code of 1986, as proposed to be inserted by section 401(a), strike subparagraph (F) and insert the following new subparagraph (F):

1 “(F) DEPARTMENT OF VETERANS AF-
2 FAIRS.—Enrollment in the annual system of pa-
3 tient enrollment maintained by the Secretary of
4 Veterans Affairs under section 1705(a) of title
5 38, United States Code.”.



AMENDMENT TO H.R. 3200
OFFERED BY MR. BUYER OF INDIANA

In subtitle B of title II of division I, add at the end
the following new section:

1 **SEC. 209. REIMBURSEMENT OF SECRETARY OF VETERANS**

2 **AFFAIRS.**

3 Notwithstanding any other provision of this Act, the
4 Secretary of Veterans Affairs may seek reimbursement
5 from the public health insurance option, and the public
6 health insurance option shall provide such reimbursement,
7 in any case in which the Secretary of Veterans Affairs
8 would be authorized to seek reimbursement from a simi-
9 larly situated private health insurance company.

In subsection (c) of section 59B of the Internal Revenue Code of 1986, as proposed to be inserted by section 401(a), add at the end the following new paragraph (6):

1 “(6) MEMBERS OF THE ARMED FORCES ON AC-
2 TIVE DUTY.—Any individual who is a member of the
3 Armed Forces who serves on active duty for a period
4 of more than 30 days during a taxable year shall be
5 treated for purposes of this section as covered by ac-
6 ceptable coverage during both such taxable year and
7 the following taxable year.”.



**AMENDMENT TO THE AMENDMENT IN THE
NATURE OF A SUBSTITUTE TO H.R. 3200
OFFERED BY MR. BUYER OF INDIANA**

(AINS-EC_001)

At the end of section 311, insert the following new paragraph:

1 (4) NATIONAL GUARD AND RESERVE DUTY.—
2 With respect to an employee who is a member of a
3 reserve component of the Armed Forces and is serv-
4 ing on active duty for a period of more than 30
5 days, an employer is deemed to meet the require-
6 ments of this section for the period that such em-
7 ployee is serving on active duty regardless of wheth-
8 er the employer meets the requirements under para-
9 graphs (1) through (3), section 312, or section 313.

In section 312(a)(1), strike the period and insert “,
or the employer is covered under section 311(4).”.
