24	(2) General Walsh has held a wide variety of
25	Army command and staff assignments, including-

4	(B) Environmental Task Force Leader,
5	Fort Stewart, Georgia;
6	(C) Executive Officer, 92nd Engineer Bat-
7	talion, Fort Stewart, Georgia, and Saudi Ara-
8	bia;
9	(D) Project Engineer and Assistant Area
10	Engineer, Baltimore District;
11	(E) Construction Officer, 18th Engineer
12	Brigade, Darmstadt, Germany; and
13	(F) Commander, Company B, 94th Engi-
14	neer Battalion, Darmstadt, Germany.
15	(3) General Walsh has received several awards
16	of the United States Army, including 2 Bronze
17	Stars, 4 Legions of Merit, and numerous lesser
18	awards.
19	(4) On October 27, 2010, the Committee on
20	Armed Services of the Senate unanimously approved
21	the nomination of General Walsh to the rank of
22	Major General, United States Army.
23	(5) General Walsh's nomination was unreason-
24	ably delayed on the floor of the Senate for 7 months.

1	(6) On May 19, 2010, the nomination of Gen-
2	eral Walsh to Major General of the United States
3	Army was confirmed by the United States Senate by
4	unanimous consent.
5	(7) On June 2, 2010, Brigadier General Walsh
6	was formally promoted to the rank of Major Gen-
7	eral.
8	(b) Sense of Congress.—It is the Sense of Con-
9	gress that General Walsh should be congratulated for his
10	promotion to the rank of Major General, United States
11	Army, and should be commended for his duty and dedica-
12	tion to the United States, to the United States Army, and
13	to the Corps of Engineers.
