RESOLUTION

To eliminate floor privileges and access to Member exercise facilities for registered lobbyists who are former Members or officers of the House.

1 *Resolved,*

1 **SECTION 1. FLOOR PRIVILEGES OF FORMER MEMBERS**
2 **AND OFFICERS.**

3 Clause 4 of rule IV of the Rules of the House of Rep-
4 resentatives is amended to read as follows:

5 “4. (a) A former Member, Delegate, or Resident
6 Commissioner; a former Parliamentarian of the House; or
7 a former elected officer of the House or former minority
8 employee nominated as an elected officer of the House
9 shall not be entitled to the privilege of admission to the
10 Hall of the House and rooms leading thereto if he or she—

11 “(1) is a registered lobbyist or agent of a for-
12 eign principal as those terms are defined in clause
13 5 of rule XXV;

14 “(2) has any direct personal or pecuniary inter-
15 est in any legislative measure pending before the
16 House or reported by a committee; or

17 “(3) is in the employ of or represents any party
18 or organization for the purpose of influencing, di-
19 rectly or indirectly, the passage, defeat, or amend-
20 ment of any legislative proposal.

21 “(b) The Speaker may promulgate regulations that
22 exempt ceremonial or educational functions from the re-
23 strictions of this clause.”.

1 **SEC. 2. PROHIBITING ACCESS TO MEMBER EXERCISE FA-**
2 **CILITIES FOR LOBBYISTS WHO ARE FORMER**
3 **MEMBERS OR OFFICERS.**

4 (a) IN GENERAL.—The House of Representatives
5 may not provide access to any exercise facility which is
6 made available exclusively to Members and former Mem-
7 bers, officers and former officers of the House of Rep-
8 resentatives, and their spouses to any former Member,
9 former officer, or spouse who is a lobbyist registered under
10 the Lobbying Disclosure Act of 1995 or any successor
11 statute or agent of a foreign principal as defined in clause
12 5 of rule XXV. For purposes of this section, the term
13 “Member of the House of Representatives” includes a Del-
14 egate or Resident Commissioner to the Congress.

15 (b) REGULATIONS.—The Committee on House Ad-
16 ministration shall promulgate regulations to carry out this
17 section.
