Congressman Lincoln Diaz-Balart:

Committed to Serving the Residents of Southwest Broward County

As the Vice-Chairman of the House Committee on Rules, I have taken important legislation to the floor of the House of Representatives for debate and passage. Below are some recent examples of legislation that I have taken to the floor and seen passage of:

The Gasoline for America's Security (GAS) Act

We have not built an oil refinery in the United States since 1976, and the ones that we have are running near capacity. The GAS Act seeks to remove some of the obstacles that have prevented the construction of new oil refineries. Bringing new refineries online will prevent our reliance on foreign sources of refined products and will also allow us to have enough refinery capacity to meet the needs of our growing economy while providing a backup if any of our refineries are shut down for an extended period of time. (H.R. 481 passed the House on 10/07/2005)

The Energy and Water Development Appropriations Act

This legislation appropriates almost \$30 billion for the U.S. Army Corps of Engineers, the Departments of the Interior and Energy, and several independent agencies. The legislation provides the resources necessary to address the energy and water needs of our country. Included in this legislation are appropriations of \$137 million for the restoration of the Everglades. With these appropriations, restoration of this environmental treasure will continue to move forward expeditiously and effectively. (H.R. 291 passed the House on 05/24/2005)

Disaster Assistance

After Hurricanes Katrina and Rita struck, we quickly responded with several pieces of legislation to address the needs of the hurricane-ravaged



areas. Some of the bills increased aid through the National Flood Insurance program, the Student Grant Hurricane and Disaster Relief Act, the Temporary Assistance for Needy Families Emergency Response and Recovery Act, and a supplemental emergency appropriations bill to help pay for the recovery effort. (H.R. 426 passed the House on 09/08/2005)

The Departments of Transportation, Treasury, and Housing and Urban Development Appropriations Act

The legislation appropriates \$133.4 billion for our national transportation and housing needs and for the federal judiciary. The bill includes almost \$37 billion in funds for our highway system. These funds will make much needed improvements in our critically important highway system. Also included is \$25 million to hire and train 595 new air traffic controllers for airports such as Miami International and Ft. Lauderdale/Hollywood International. One million dollars in funds will be used for the construction of a Broward County bus service facility. (H.R. 342) passed the House on 06/28/2005)
