79th Street Rotunda - \$12,000,000:

Restoration and Reconstruction of the West 79th Street Rotunda, New York, NY.

Battery Park Bikeway - \$1,600,000:

Construction of the Battery Park Bikeway, New York, NY.

Brentwood Traffic Mitigation - \$20,000,000:

Design and construct, rehabilitate or replace local connector and parallel roads in connection with the functioning or environmental mitigation of the impacts of truck/rail intermodal sites on Long Island, NY.

Coney Island Area Improvements - \$9,000,000:

Plan, design and construct transportation connections, including pedestrian safety improvements, throughout the Coney Island vicinity of West 10th Street, Wonder Wheel Way, West 17th Street and Riegelmann Boardwalk, Brooklyn, NY.

Coney Island Riegelmann Boardwalk - \$2,000,000:

Design and reconstruction of Riegelmann Boardwalk from West 37th Street to Brighton 14th Street, Brooklyn, NY.

Coney Island Surf Avenue & West 8th Street - \$6,400,000:

Design and Reconstruction of Surf Avenue street crossing, West 8th Street to the Riegelmann Boardwalk, and Surf Avenue Pedestrian bridge and causeway, Brooklyn, NY.

Cross Harbor Freight Movement Project - \$1,083,000,000:

Planning, design, engineering, environmental review, right-of-way acquisition, rehabilitation and construction of Cross Harbor Freight Movement Project, New York & New Jersey.

East River Esplanade Bikeway - \$4,800,000:

Design and construction of East River Esplanade A on the East River Waterfront Esplanade, New York, NY.

Gansevoort & West Street Improvements - \$2,480,000:

Plan, design and construct pedestrian safety improvements along West Street and Gansevoort Street to Washington Street, New York, NY.

The High Line Project - \$56,000,000:

Plan, design, engineer, conduct environmental review, rehabilitate and reconstruct Section 3 of the High Line, New York, NY.

Penn Station Metro-North Access Project - \$15,000,000:

Conduct environmental review and design for Penn Station Access, MTA Metro-North service to Penn Station, including new rail stations, New York, NY.

Rockland-Westchester-Lower Manhattan Ferry Service - \$9,000,000:

Develop, construct and conduct ferry service between Haverstraw (Rockland County) to Yonkers (Westchester County) to World Financial Center and Pier 11-Wall Street in Lower Manhattan, New York, NY.

Seventh Avenue and West 11th-13th Street Improvements - \$12,000,000:
