

- **BP Forms Gulf of Mexico Oil Spill Escrow Trust** BP announced today that it has established a trust and made a \$3 billion initial deposit of the previously-announced \$20 billion escrow account to pay legitimate claims arising from the Deepwater Horizon incident and the resulting oil and gas spill. - BP names Mike Utsler its representative to Unified Area Command in New Orleans - Mike Utsler will be BP's lead representative in the Unified Area Command (UAC) and chief operating officer for the BP Gulf Coast Restoration Organization. Utsler, who has served as BP's commander in the Houma incident command post since April, replaces Doug Suttles, who has led BP's overall response to the spill and served as BP's representative in the UAC. The Gulf Coast Restoration Organization will manage BP's ongoing response and restoration activities from the Deepwater Horizon oil spill. The organization will maintain offices in each of the affected states, including Florida, Mississippi, Alabama, Louisiana, and Texas. - **Static Kill and Cementing** The MC252 well has been shut-in since July 15; there is currently no oil flowing into the Gulf. BP continues to work with the guidance and approval of the National Incident Commander and the leadership and direction of the federal government. August 5th pressure tests indicated there is an effective cement plug in the casing. BP believes the static kill and cementing procedures have been successful.
- **Relief Wells** BP continues to progress the relief well operations that commenced on May 2. The well is currently at a measured depth of 17,909 feet. Progressing towards the intersect with the MC252 well will involve drilling alternating with ranging runs to confirm proximity to the well. Depending upon weather conditions, August 15th is the current estimate of the most likely date by which the first relief well will intercept the MC252 well annulus. Operations on the second relief well, which started May 16, have been suspended at a measured depth of 15,874 feet, so as not to interfere with the completion of the first relief well.

State Summaries – Shoreline Operations

LOUISIANA

OFFSHORE: Currently only sheening found, not suspected to be MC 252 oil. **SHORELINE**: Currently Oiled: Heavy to Moderate: 123.6 miles; Light to Trace: 263.5 miles; Total: 387.1 miles.

INSHORE: Currently only light oiling found.

WILDLIFE: 238 wildlife specialists utilized 4 flights and 86 boats to search for and recover impacted wildlife.

AIR OPERATIONS: 53 flights

BOOM: Deployed 15,800' of hard boom, recovered 21,445' of hard boom; a net recovery of 5,645' of hard boom in the last 24 hrs. Recovered boom is stranded, damaged, or a hazard to navigation.

MISSISSIPPI

SHORELINE: Crews responded to light impact of tarballs in Hancock County. Crews continued cleanup on Belle Fontaine Beach, Petit Bois, Cat, Horn, and Ship Islands. Crews conducted night operations on Hancock Beach.

NEARSHORE: Vessels of Opportunity conducted boom recovery, environmental sampling, wildlife support and tarball collection. All Task Forces continued scouting and patrolling for skimmable oil patches/sheen. All decontamination sites continued building up capacity. **BOOM**: Crews continued boom maintenance in Jackson, Harrison, and Hancock Counties. Hard, absorbent, and snare boom recovered per directions from Mississippi State officials. Total deployed this period 0'. Recovered in last 24 hrs 37,400'. Net recovery in last 24 hrs 37,400'.

ALABAMA

SHORELINE: No new oiling reported in Alabama. Beach cleaning machines conducted night operations on Dauphin Island and in Baldwin County. All daytime operations were secured due to thunderstorms and lightning around 1330.

NEARSHORE: Operations of all Task Forces impacted by weather. Vessels of Opportunity conducted boom recovery, environmental sampling, wildlife support and tarball collection. All Task Forces continued scouting and patrolling for skimmable oil patches/sheen. All decontamination sites continued building up capacity.

BOOM: Crews continued boom maintenance and minor repairs in all divisions. Crews continued phased boom recovery in Baldwin and Mobile Counties. Total deployed for this period 0'. Recovered in last 24 hrs 2,500'. Net recovery in last 24 hrs 2,500'.

FLORIDA

SHORELINE: No new oiling reported in the state of Florida. Re - oiling was reported in Escambia, Santa Rosa, Okaloosa and Walton Counties. Crews continued manual cleanup in Escambia, Santa Rosa, Okaloosa, Walton, and Bay Counties. Crews conducted mechanical beach cleaning in Okaloosa and Walton Counties and conducted mechanical and manual beach cleaning at night in Escambia and Santa Rosa Counties.

NEARSHORE: Vessels of Opportunity conducted boom recovery, environmental sampling, wildlife support and tarball collection. All Task Forces continued scouting and patrolling for skimmable oil patches/sheen. Optimization of offshore Vessels of Opportunity fleet size continues. All decontamination sites continued building up capacity.

BOOM: Crews continued boom maintenance and recovery in Escambia, Santa Rosa, Okaloosa, Walton, Gulf, Franklin, Wakulla and Jefferson Counties. Total deployed this period 0'. Recovered in last 24 hrs 28,500'. Net recovery in last 24 hrs 28,500'.

TEXAS

SHORELINE: No Shoreline Assessment and Cleanup currently scheduled. **INSHORE:** Total recovered to date 118 cubic yards of oily solids.

NEARSHORE: Nothing significant to report.
OFFSHORE: Nothing significant to report.
WILDLIFE: Total wildlife to date: 1 injured sea turtle, 1 diseased bird (live), 2 injured birds (live), 1 bird/3 turtles found deceased - no visible oil on any wildlife.
BOOM: None utilized at this time.
