Relief Well / Intercept – BP continues to work with Thad Allen, National Incident Commander, to determine the best course of action regarding the final intercept of the relief well. BP engineers and the federal science team continue to evaluate ongoing test results and best ways to mitigate risks associate with intercepting the annulus and increasing the pressure in the annulus.

BP Readies for Transfer to Gulf Coast Claims Facility - BP's claims team, which has paid \$368 million to individuals and businesses, is in the final stages of preparing to transfer responsibility for individual and business claims related to the oil spill in the Gulf of Mexico to the Gulf Coast Claims Facility (GCCF) and Ken Feinberg on August 23.

In order to clarify the next steps and to ensure an orderly and efficient transfer of files and data, BP announced the following:

- BP will accept new claims into its system through Wednesday, August 18. From August 19 - 22, individuals and businesses will be asked to file a claim when the GCCF is operational on August 23.
- BP's Immediate Action Claims Team will continue to operate through Sunday, August 22, for existing claimants only. This team can be contacted at (800) 573-8249 and will work with those who have real emergencies with regard to an existing claim.
- Government entity claims will continue to be handled by BP's claims team. Effective

- BP will continue to take phone calls regarding fraud at (877) 359-6281.

BP has made more than \$102 million in claims payments during the first 16 days of August. Payments to claimants in past months were \$134 million in July, \$93 million in June, and \$39 million in May, making this one of the largest claim payment programs conducted in a three and a half month period.

The GCCF will be announcing new contact and claims information this week. BP also will ensure that anyone contacting its existing claims phone lines or web sites is referred to the GCCF. Effective August 23, GCCF will be the only authorized organization managing business and individual claims related to the Deepwater Horizon Incident.

BP Provides \$52 million to Fund Behavioral Health Support Across Gulf Coast - BP announced that it is providing \$52 million to federal and state health organizations to fund behavioral health support and outreach programs across the US Gulf Coast region.

SHORELINE: No new oiling reported. Crews continued beach cleaning operations on Harrison County beaches and removed tarballs from beaches west of Bayou Caddy. Crews conducted night operations in Hancock County.

NEARSHORE: Vessels of Opportunity assisted in wildlife, NOAA, and NRDA. Submerged Oil Assessment teams build up finished.

BOOM: Total deployed this period is 0 ft. Recovered 19,450 ft in last 24 hrs. Net recovery in last 24hrs is 19,450 ft. Crews removed containment boom and sorbent boom from marshes in Hancock County.

ALABAMA

SHORELINE: No new oil impacts reported. Crews continued beach cleaning in Gulf Shores, Ft. Morgan, and Orange Beach. Nine beach cleaning machines continued operations in Baldwin County.

NEARSHORE: Vessels of Opportunity continued boom removal in Baldwin County.

BOOM: Total deployed for this period is 0 ft. 34,150 ft recovered in last 24 hrs. Net recovery in last 24hrs is 34,150 ft. Crews continued phased boom removal in Baldwin and Mobile County.

FLORIDA

SHORELINE: No new oiling reported in the state of Florida. Re - oiling in the form of tarballs continued in Escambia, Santa Rosa, Okaloosa and Walton Counties. Crews performed limited manual and mechanical operations due to weather. Night operations conducted in Escambia, Santa Rosa, and Okaloosa Counties where weather permits.

NEARSHORE: Vessels of Opportunity and Inland Water Strike Teams were secured due to weather.

BOOM: Total deployed this period is 0 ft. 21,600 ft recovered in last 24 hrs. Net recovery in last 24 hrs is 21,600 ft. Boom removal operations were minimal due to adverse weather.
