BP Completed Flushing of MC252 Subsea Equipment and Continues Ambient Pressure Testing - Ambient pressure testing continues to help determine whether the BOP can be safely removed from the wellhead. This test is expected to conclude Saturday morning. Once this test is complete, next steps will be to determine if the drill pipe in Macondo BOP can be removed.

BP is complying with government directives concerning the BOP from the Macondo well. We are following Admiral Allen's instruction to bring it to the surface following completion of tests to determine that removing it from the well will be safe. The U.S. Government will then preserve it at a facility in New Orleans specified by the Marine Board of Investigation. Additionally, we are preparing responses to a recent request from the Department of the Interior that BP and other parties provide input into the types of inspection, testing and analysis that government agencies or others might conduct on the BOP.

Relief Wells – The *Development Driller III* remains onsite and is approximately 50 feet from the intercept point with the Macondo wellbore. The *DDIII* is standing by pending completion of the Macondo blowout preventer activities.

Claims Transition to Gulf Coast Claims Facility Underway - As agreed, Kenneth Feinberg and the Gulf Coast Claims Facility (GCCF) will take over the claims program. Effective August 23, the BP Claims Process for individuals and businesses will transition to GCCF, an independent organization that will review, evaluate and make determinations about claims related to this incident. Going forward, BP will continue to process state and local government claims.

To clarify next steps and ensure an orderly and efficient transfer of files and data, BP has announced the following:

- BP will accept new claims into its system through Wednesday, August 18. From August 19-22, individuals and businesses will be asked to file a claim when the GCCF is operational on August 23.
- BP's Immediate Action Claims Team will continue to operate through Sunday, August 22, for existing claimants. This team can be contacted at (800) 573-8249 and will work with those who have real emergencies with regard to an existing claim.
