BP Sends Report to the U.S. Government that reviews “Lessons Learned” – Today, BP delivered a report to the U.S. Bureau of Ocean Energy Management, Regulation and Enforcement titled, “Deepwater Horizon Containment and Response: Capabilities and Lessons Learned.” One of the ways BP is seeking to make things right in the aftermath of the tragic Deepwater Horizon incident is to share – with the industry, governments and other stakeholders – the lessons that have been learned and the capabilities developed during the response effort. Removal of BOP and Capping Stack – On Thursday, the Capping Stack was successfully removed from the BOP and on Friday, the *Q4000* was able to successfully remove the BOP from the wellhead. There was no broken drilling pipe stuck in the BOP. Once all the equipment has been cleared away from the Macondo wellhead, and the wellhead has been inspected and is prepared to be attached to the new BOP, the *Development Driller II* will place the new BOP onto the well and the *Development Driller III* will proceed with the relief well.

BP is complying with government directives concerning all recovery of equipment from the Macondo well. We are following Admiral Allen's instruction to bring equipment it to the surface. The U.S. Government will then preserve it at a facility in New Orleans specified by the Marine Board of Investigation. Additionally, we are responding to a request from the Department of the Interior that BP and other parties provide input into the types of inspection, testing and analysis that government agencies or others might conduct on the BOP.

Relief Wells – The *Development Driller III* remains on standby and the first relief well is approximately 50 feet from the intercept point with the Macondo wellbore. Once the new BOP is on the Macondo wellhead, the *DDIII* will proceed with drilling and ranging operations in the first relief well. The new BOP on the Macondo wellhead will provide a more robust system to contain any pressure put into the Macondo well during intercept and a bottom kill operation.

Claims Transition – BP has transitioned its individual and business claims program to the Gulf Coast Claims Facility (GCCF). Their comprehensive website is located at: www.gulfcoastclaimsfacility.com.

Government Claims – BP’s claims team will continue to handle *government* claims and funding requests. *James Witt and Associates* has been retained to assist in outreach to state and local governments. *Witt* representatives will provide advice to government entities about needed documentation, will answer questions, and provide feedback from claimants to BP regarding the claims process.
