

Relief Wells – On Thursday at 4:30 pm CDT, the *Development Driller III* intercepted the Macondo well annulus. Total measured depth of the intercept was 17,977 feet below the surface of the ocean. Operations conducted bottoms up circulation, which returned the contents of the well's annulus to the rig for evaluation. Testing of the drilling mud recovered from the well indicated that no hydrocarbons or cement were present at the intersect point, indicating that the annulus has integrity at that depth. Therefore, no annulus kill is necessary and the annulus cementing will proceed as planned. It is expected that the Macondo well will be completely sealed on Saturday.

Removal of BOP and Capping Stack – The Capping Stack and failed BOP were successfully removed from the Macondo wellhead. The BOP was shipped to a NASA facility at Michoud, LA, where investigation teams will follow agreed upon disassembly protocols. The Capping Stack is onboard the vessel *Enterprise* and being disassembled pursuant to instructions from the Incident Commander.

Claims Transition – BP transitioned the individual and business claims program to the Gulf Coast Claims Facility (GCCF) on August 23.
