The new 110th Congress implemented a work-day calendar changing the number of days working from 3 to 5 per week, greatly expanding the actual time Representatives would have to conduct the people's business in committees, working on legislation, and voting on the floor in Washington, DC. This has diminished the Mondays or Fridays normally spent working in the Members' home district.



this busy schedule our office has continued to conduct important meetings, whether in Washington, DC or in Southern California:

### **Bureau of Reclamation**

Meeting with Commissioner Bob Johnson in the Capitol's Rayburn Room to request assistance to our communities on local water recycling and groundwater cleanup programs, known as Title 16 projects. Congresswoman Napolitano is Chair of the Subcommittee on Water &

Power, which has jurisdiction over the Bureau of Reclamation and covers 17 western states.

# Environmental Protection Agency

Meeting with Benjamin Grumbles, Assistant Administrator, EPA Office of Water to discuss Global Warming that is causing very atypical and unusual rainfall patterns across the United States. Our residents must realize the seriousness of our water shortages and help by conserving as much water as possible. Solutions to prepare for unpredictable rainfall patterns were discussed and included cleaning up our local groundwater aquifers and recycling, reusing and storing water from local rainfall.

### **Secretary of Transportation**

Congresswoman Napolitano joined a helicopter tour of Los Angeles County, the Alameda Corridor, and the 5, 10, and 60 freeways with U.S. Department of Transportation Secretary Mary Peters, followed by a Los Angeles and Long Beach port tour. Secretary Peters was shown the major congestion on the I-5 freeway and the serious safety problems created by the railroad grade crossing throughout our district. The Secretary was well versed and acknowledged the traffic congestion, air pollution, and rail safety issues in Southeast Los Angeles County, especially cognizant of the expected increased auto traffic of the I-5 and of the Alameda Corridor East railroad project. She received the latest Gateway Cities and San Gabriel Valley Council of Governments reports from Congresswoman Napolitano.

# Union Pacific Railroad and LA County Fire Dept.

nion Pacific Railroad Chairman Jim Young visited our office to discuss safety issues of UP railroads and their affect on our neighborhoods, expressing citizens concerns over the infrastructure and safety of railroad tracks and grade crossings, especially after the 5 local train derailments of the past few years. Mr. Young reported their recent investment of more than \$60 million in its two main Los Angeles train lines, upgrading to new track and new concrete ties. The Congresswoman thanked Mr. Young for putting in this new infrastructure, but also expressed her concern on how their work required the closing of multiple grade crossings, necessitating the creation of Fire Department emergency service crews on both sides of tracks for handling any emergencies, which then cost our Los Angeles County Fire Department additional expenditures and extra manpower. The Congresswoman requested that the railroad reimburse the LACFD for these services, resulting in a \$55,466.40 payment to them.

### Assistance to Small Business

BA Assistance available to Small Businesses! Your business may be eligible for low interest disaster loans from the U.S. Small Business Administration. These disaster loans will assist small businesses who have been financially impacted by the low temperatures and freezing conditions that occurred from January 6 to January 19, 2007, and do not have the financial ability to offset this impact without hardship.

Small businesses may qualify for **Economic Injury Disaster Loans (EIDLS)** of up to \$1.5 million to help meet financial obligations and operating expenses. Loans have an interest rate of 4% and a maximum term of 30 years. To date, SBA has approved more than \$5.4 million in loans.

### **Army Corps of Engineers**

Meeting in our office with John Paul Woodley, Secretary of Army Civil Works, and with Maj Gen Don Riley, Director of Civil Works for the Army Corps on the preparation of a study that evaluates the restoration of natural environment, prevention of flooding, improvement to water quality, and an increase in recreational opportunities along the San Gabriel River in partnership with the city of Pico Rivera and LA County Supervisor Gloria Molina. The Corps affirmed their commitment to this project and will continue to provide support in concert with community needs.

### Legislation Passed in '07

Congress is committed to fulfilling its promise to reflect the values and priorities of the American people.

"There is a new tone for the 110th Congress, more cooperative, with increased consensus and compromise extending beyond party lines," Congresswoman Napolitano noted.

"This has been a strong beginning of the 110th Congress and for our communities, a very important step in the right direction. Yet while we have been on a 5-day work schedule in Washington, we must not ignore that our presence is still needed in our local communities," concluded Rep. Napolitano.

The following bills, all with the Congresswoman's full support, have been passed in the House of Representatives since the start of the 110th Congress in January:

- Ethics Reform
- Restoring Fiscal Responsibility
- Implementing the 9/11 Commission Recommendations
- Increasing the Minimum Wage
- Expanding Stem Cell Research
- Requiring Negotiation for Lower Prescription Drug Costs
- Cutting Interest Rates on Student Loans
- Ending Subsidies for Big Oil and Investing in Renewable Energy

### Immigration Update

The Security Through Regularized Immigration and a Vibrant Economy (STRIVE) Act of 2007, introduced on March 22 as H.R. 1645, is co-sponsored by Congresswoman Napolitano. This bipartisan, long-overdue comprehensive immigration reform addresses many, if not most, of the problems plaguing our current immigration system:

- Strengthens border security, adding more border personnel, funding for cutting-edge technology, and develops multilateral partnerships with our neighbors.
- Creates a new worker program: issues three-year worker visas to 400,000 immigrants to occupy jobs that American workers cannot fill. The workers are guaranteed fair wages, safe working conditions, and can change jobs without losing their visas, which will be renewable once. Immigrants in the fifth year of their stay may self petition for citizenship.
- Overhauls family-based and employment-based visa systems to reduce the decade of application backlog.
- Allows them to pay a \$1,000 fine, pass a background check to obtain conditional status with

- work and travel authorization for a six-year period. If during that period an immigrant holds down a job, obeys the law, learns English/US civics, and pays taxes, they may be eligible to adjust their immigration status pending a second \$1,000 fine and must leave the US, then re-enter legally.
- Increases penalties for crimes committed by immigrants and combats the use of fake documents.
- Improves employment verification by setting up a biometric employee identification system and penalizing employers who do not comply with the system.
- Increases resources for immigration courts to process more cases, helps soldiers naturalize, and provides relief to families of immigrant 9/11 victims.

The STRIVE Act will bring immigrants out of the shadows, protect immigrants' rights, reunite families, and help increase taxes paid to the government, improving our economy and securing our homeland. The United States has been a land of immigrants and will continue our legacy far into the twenty-first century.

### Mental Health Impacts our Communities, Economy

The Congresswoman joined her colleagues Rep. Patrick Kennedy (D-RI) and Rep. Jim Ramstad (R-MN) on Saturday, February 10th, for a field hearing held at Cerritos College on mental health and addiction treatment by insurance companies, hearing testimony from state, county, and community members whose lives have been impacted by mental illness and chemical addiction.

Most health insurance plans impose short limits on mental health and addiction coverage, leaving their members to pay for obtaining care as they face the burdens of these illnesses on their own.

In 2006 untreated addiction cost our economy \$400 billion and untreated mental illness over \$150 billion. These illnesses are diagnosable and treatable. Congress must act not only to erase the stigma, but also to ensure that health insurance companies provide adequate coverage and proper long term treatment for healthy lives, since the risk of relapse ultimately will cost our communities and economy so much more.

Congresswoman Napolitano delivered a keynote address at the National Association of Latino Elected and Appointed Officials (NALEO) February 17 on the impact of Post Traumatic Stress Disorder on veterans and their families, especially after 2, 3 or 4 deployments.

The Congresswoman joined her colleagues on March 7 in cosponsoring the Paul Wellstone Mental Health and Addiction Equity Act, H.R. 1424, calling for equal coverage for mental health and addiction treatment, eliminating discriminatory provisions that prevent Americans with mental health and addiction disorders from obtaining critically needed services. She is a cosponsor of H.R. 1622, Mental Health Security for America's Families in Education, an act that assists universities in communicating with parents if a student is at an increased risk for suicide, homicide, or assault. To recognize May as Mental Health Month she introduced a resolution in the House of Representatives, H.Con.Res 130, on April 25.

### Veterans & Families Know Your Rights

### Requesting medical care outside the VA:

sually when veterans need specialty care or are not in close proximity to receive services from VA medical facilities, the VA can authorize medical care services in their community for veterans that meet the eligibility requirements. The VA authorization will be specific and will indicate the medical services that the VA approves, the length of period for treatment, and the amount that VA will pay. These services **must** be approved before the veteran receives treatment.

The Reserve Education Assistance Program (REAP)

EAP was established as a part of the

National Defense Authorization Act for Fiscal Year 2005. It is a new Department of Defense education benefit program designed to provide educational assistance to members of the Reserve components called or ordered to active duty in response to a war or national emergency (contingency operation) as declared by the President or Congress. This new program makes certain reservists who were activated for at least 90 days after September 11, 2001 either eligible for education benefits or eligible for increased benefits. The following programs are available:

Vocational Programs

Independent Study or Distance Learning Programs
Entrepreneurship Courses

Survivors' and Dependents' Educational Assistance Program (DEA)

The Veterans Benefits, Health Care, and Information Technology Act of 2006 made eligible for benefits the spouse or child of a person

who the VA determines has a service-connected permanent and total disability, and at the time of VA's determination is a member of the Armed Forces who is hospitalized or receiving outpatient medical care, services, or treatment, and is likely to be discharged or released from service

for this service-connected disability.

Dependents' Educational Assistance is a **new** program that provides education and training opportunities to eligible dependents of certain veterans. The program offers up to 45 months of education benefits. These benefits may be used for degree and certificate programs, apprenticeship, and on-the-job training.

### **Record Demand for Passports**

merican citizens applying for passports have increased dramatically. Updates from the State Department may prove helpful if you are seeking a passport. (See website address below)

- Currently, a passport is **not** needed for land or sea travel to the **Caribbean**, **Bermuda**, **Canada** or **Mexico**.
- 2. If you need to reach a representative of the State Department by phone, call 1-877-487-2778. Due to high call volume, please call only if you are traveling within the next two weeks.

- Routine processing time for a passport is now about ten weeks. Expedited processing is about four weeks.
- 4. Be aware: there is an optional question on the passport application asking for departure date and destination please remember to fill that out, as it helps process your passport application in time for your trip.
