Dear Madam Secretary:

We are writing to express our opposition to the decision made by the Department of State to block the importation of nearly one million American-made M1 rifles from the South Korean government—a transaction that had previously been approved by this Administration last year.


These vintage semiautomatic rifles are of historical significance to firearms enthusiasts and collectors across the country, particularly for those veterans who served their country honorably in Korea and Vietnam.

The claim that the importation of the firearms should be blocked because they “could potentially be exploited...for illicit purposes” is just a reiteration of tired arguments by gun control advocates. Possession of these antique firearms by Americans is lawful, and potential purchasers would be required to go through the same background check process as they do for new firearms. Furthermore, these are the very same types of rifles that have been sold by the federal government to civilians for decades through the Civilian Marksmanship Program.

If these classic rifles are allowed to be destroyed (which we fear is, presumably, one of the “alternative options to dispose of these firearms”), a valuable piece of American history will be sacrificed for the sake of political expediency.

Therefore, we are writing to respectfully urge you to reconsider this decision and to permit these M1 rifles to be bought from the South Korean government and sold to law-abiding Americans. We appreciate your attention to this matter and look forward to hearing from you soon.
