H.R. ____To amend Public Law 110-196 to provide for a temporary extension of programs authorized by the Farm Security and Rural Investment Act of 2002 beyond April 18, 2008 (*Peterson, D-MN*)

<u>Order of Business</u>: The bill is scheduled to be considered on Wednesday, April 16, 2008, under a motion to suspend the rules and pass the bill.

Summary: H.R. _____ would extend agricultural programs under the Farm Security and Rural Investment Act of 2002 (the "farm bill") through April 25, 2008. The current provisions are set to expire on April 18, 2008.

<u>Additional Background</u>: On July 27, 2007, the House passed H.R. 2419, the Farm, Nutrition, and Bioenergy Act of 2007, which would have extended farm bill programs for five years, by a vote of <u>231-191</u>. On December 14, 2007, the Senate passed their version of the legislation but House and Senate conferees have yet to file a conference report. Committee Action: H.R. ____ will likely be introduced today, April 16, 2008.

<u>Cost to Taxpayers</u>: A CBO score for H.R. ____ was not available at press time.
