# Senate Amendment to H.R. 4899—FY 2010 Supplemental Appropriations Act (*Rep. Obey, D-WI*)

<u>Order of Business</u>: The bill is scheduled to be considered on July 27, 2010 under a motion to suspend the rules and pass the bill.

**Summary**: The bill provides \$45.5 billion of new discretionary spending, and \$13.4 billion of new mandatory spending. The most notable components of this spending are listed in the tables below:

#### **Other Items:**

- The legislation rescinds \$111.5 million of funding from the Digital-to-Analog Converter Box Program.
- Rescinds approximately \$73 million of Department of Defense funding.
- Rescinds approximately \$11 million of Homeland Security funding.
- Rescinds \$25 million of unobligated balances from Safety Belt Performance Grants program.
- Rescinds \$44 million of unobligated balances from the Consumer Assistance to Recycle and Save Program.
- Allows advances on the Oil Spill Liability Trust Fund, up to a maximum of \$100 million for each advance, to respond to the oil spill in the Gulf.
- Designates all spending as emergency.

**Potential Conservative Concern:** Some conservatives may be concerned that the legislation increases the deficit, and does not contain offsets for some of the non-war related spending.

<u>**Committee Action**</u>: A very dissimilar version of the legislation passed the House on March 24, 2010 by a vote of <u>239-175</u>. The Senate passed its version of the bill on May 27, 2010 by a vote of <u>67-28</u>. The House subsequently, on July 1, 2010, passed another version of the bill that the Senate failed to enact cloture on (see the RSC Legislative Bulletin <u>here</u>).

<u>Administration Position</u>: The Administration <u>issued</u> a Statement of Administration Policy (SAP) in favor of the Senate-passed bill on May 24, 2010.

**Does the Bill Expand the Size and Scope of the Federal Government?**: Yes, the bill increases federal spending by approximately \$59 billion.

**Does the Bill Contain Any New State-Government, Local-Government, or Private-Sector Mandates?**: No CBO report listing any such mandates is available.

**Does the Bill Comply with House Rules Regarding Earmarks/Limited Tax Benefits/Limited Tariff Benefits?**: No committee report citing any potential earmarks is available.

**<u>Constitutional Authority</u>**: No statement of constitutional authority is available.
