Dear Chairman Frank:

The organizations signed below are writing to express our support for the amendment sponsored by Congresswoman Judy Biggert and Congressman Sam Graves to restore Section 1099F of the Conference Base Text (H.R. 4173). The Small Business Fairness and Regulatory Transparency Amendment is necessary to ensure the newly created independent agency is sensitive to small business and provides information to the public through a transparent regulatory process.

New jobs primarily come from the small business sector of our economy. Small businesses have created about two out of every three net new jobs in the United States since the 1970's. ¹ Nearly all net job creation since 1980 has occurred in firms less than five years old. ²

Section 1099F was the result of a bi-partisan amendment sponsored by Olympia Snowe (R-ME), Mark Pryor (D-AK), Robert Menendez (D-NJ), Lindsey Graham (R-SC), Al Franken (D-MN), Kit Bond (R-MO), Roland Burris (D-IL), and John Thune (R-SD). On Friday, 15 Blue Dog Members wrote a letter to the conference committee in support of the amendment because the provision will prevent unintended consequences of a new independent agency that could harm the small business sector.

The Small Business Fairness and Regulatory Transparency Amendment requires the Consumer Financial Protection Bureau (CFPB) to include recommendations from a small business advocacy review panel with any proposed rules that will significantly impact small firms. Additionally, the amendment requires the CFPB to inform the public of how its rules impact small business access to credit.

Small Business Advocacy Review Panels

Small business advocacy review panels are currently utilized by the U.S. Environmental Protection Agency (EPA) and the Occupational Safety and Health Administration (OSHA) under the Small Business Regulatory Enforcement Fairness Act (SBREFA) of 1996. The inclusion of small business recommendations with proposed rules promotes

transparency without slowing the important rulemaking process and helps minimize unintended consequences that can occur with one-size-fits-all regulations.³

According to the U.S. Small Business Administration, small firms shoulder a 45 percent higher burden to comply with federal regulations than their larger business competitors. This economic distortion can be eased when agencies carefully consider how their regulations will impact small firms. The small business advocacy review panels required by the Biggert-Graves amendment prevent one-size-fits-all rulemakings by forcing the CFPB to consider small business input through a 60-day process. The amendment bolsters transparency by requiring the panel reports to be published when proposed rules are issued.

Cost of Credit Analysis

Almost 90 percent of the nation's 26 million small businesses use some form of credit.⁵ Unfortunately, only half of small businesses that tried to borrow last year got all or most of the capital they needed.⁶ The Ewing Marion Kauffman Foundation, the world's largest foundation devoted to entrepreneurship, refers to credit as the "oxygen for new and young firms."⁷ The Biggert-Graves amendment requires the CFPB to document how its rules will impact the cost of credit for small firms. This will ensure the newly created CFPB is sensitive to how it will impact access to capital and the ability of new firms to grow.

We need the strength of America's small business sector to bring down unemployment and to bolster our country's standing in the global marketplace. We believe you share our desire to take every step necessary to protect Main Street while you are trying to fix the practices on Wall Street. For those reasons we ask that you strike the language in the House Proposed Amendment to Title X and restore Title X, Subtitle H, Section 1099F of the H.R. 4173 Conference Base Text. We urge for you to adopt the Small Business Fairness and Regulatory Transparency amendment as part of your conference proceedings.
