This memorandum is sent in response to your request for a list of all the "czars" in the Administration of Barack Obama and contact information for each of them. **Table 1**, below, lists the name, position, date the appointment was announced, and authority providing for the appointment (if available), for each individual. A blank in the authority column means that we were unable find a statute or executive order for the position. The positions listed are those which have been discussed in the news media or by the President as "czars," and may refer to a use of that word to convey an intense focus on an issue of great interest to the public, rather than a White House coordinating role.

Not included in the table are several foreign policy related positions that have also been referred to in the news media as "czars," whether that term is appropriate or not. Those positions include:

- Ambassador Stephen W. Bosworth, announced February 20, 2009, by Secretary of State Clinton, Special Representative for North Korea Policy;
- Ambassador Daniel Fried, announced March 12, 2009, by Secretary of State Clinton, leading the team addressing the closure of Guantanamo Bay prison;
- Major General J. Scott Gration, announced March 18, 2009, by President Obama, U.S. Special Envoy for Sudan;
- Richard Holbrooke, announced January 22, 2009, by Secretary of State Clinton, Special Representative for Afghanistan and Pakistan;
- George Mitchell, announced January 22, 2009, by Secretary of State Clinton, Special Envoy for the Middle East;
- Dennis Ross, announced February 23, 2009, by Secretary of State Clinton,
   Special Advisor for the Persian Gulf and Southwest Asia; and
- Todd Stern, announced January 26, 2009, by Secretary of State Clinton, Special Envoy for Climate Change.

We also did not include the appointment of Steve Rattner, the so-called "car czar," in the table. On February 23, 2009, President Obama announced the appointment of Mr. Rattner as Counselor to the Secretary of the Treasury, "where he will serve as an adviser on a variety of economic and financial matters, and will lead the Treasury's efforts with regard to the automobile sector." Tim Geithner, the Secretary of the Treasury, and Lawrence Summers, the Director of the National Economic Council, convened the Presidential Task Force on the Auto Industry on February 20, 2009. Several days earlier, on February 16, 2009, White House Press Secretary Robert Gibbs responded to the question, "has the President moved away from the idea of a car czar and in favor of the broad team approach?" this way:

Well, the approach that the administration has settled on I think provides a vast amount of expertise that crosses a number of governmental agencies and departments, and brings in the vast amount of experience that the administration has to deal with the auto restructuring – any auto restructuring issues .... Again, I think the President feels like the task force is an idea that combines a lot of smart people and a lot of different governmental jurisdictions with a senior advisor who has some real experience in doing

some of this restructuring and representing both the concerns of investors and bond holders, but also the livelihoods of tens of thousands of auto workers in the Midwest who need to have a seat at the table, as well.<sup>3</sup>

Section 105 of Title 3 of the *United States Code* authorizes the President to appoint and fix the pay of employees in the White House Office "who shall perform such official duties as the President may prescribe." With regard to employees at the highest pay grades, the President may appoint 25 employees at salaries that may not exceed Executive Schedule Level II (\$177,000, as of January 2009) and 25 employees at salaries that may not exceed Executive Schedule Level III (\$162,900, as of January 2009).
