New York State Department of Health: Applications will be accepted for grants to fund non-profit community-based programs to provide direct, free or reduced fee legal assistance to underserved individuals and families whose lives have been affected by diagnoses of cancer. The funded applicant will provide members of underserved priority populations with legal assistance and support in planning for long and short term legal, financial, and medical needs. The Department of Health currently expects that approximately 6 awards will be made as a result of the application process. It is expected that awards will be made to support both the infrastructure and reimbursement for counseling, education, outreach and support services provided. Department of Health and Human Services: Grants delivered through the Health Preparedness Program (HPP) are to be used to maintain, refine, and to the extent achievable, enhance the capacities and capabilities of healthcare systems, and for exercising and improving preparedness plans for public hazards including pandemic influenza. Healthcare systems eligible for these grants include hospitals and other healthcare facilities which are defined broadly as any combination of the following: outpatient facilities and centers (e.g., behavioral health, substance abuse, urgent care), inpatient facilities and centers (e.g., poison control, emergency medical services, CHCs, nursing, etc.). Ben & Jerry's Foundation: The Ben & Jerry's Foundation offers competitive grants to not-for-profit, grassroots organizations throughout the United States which facilitate progressive social change by addressing the underlying conditions of societal and environmental problems. The Foundation supports programs and projects that are examples of creative problem solving. Projects must lead to societal, institutional, and/or environmental change, address the root causes of social or environmental problems, and lead to new ways of thinking and acting. Grant applicants need to demonstrate that their projects will lead to societal, institutional and/or environmental change, address the root causes of social or environmental change.

Department of Health and Human Services: The Family and Youth Services Bureau (FYSB) is accepting applications for the Basic Center Program (BCP), which addresses runaway and homeless youth (RHY) problems. BCPs provide an alternative for runaway and homeless youth who might otherwise end up with law enforcement or in the child welfare, mental health, or juvenile justice systems. Each BCP must provide runaway and homeless youth with a safe and appropriate shelter, individual, family, and group counseling as appropriate, and aftercare. Public and non-profit private entities and coordinated networks of such entities are eligible for this program. Environmental Protection Agency: Funds are available for eligible entities to create Environmental Finance Centers (EFCs) that provide multi-media environmental finance expertise and outreach to regulated communities (e.g., states, tribes, local governments, and the private sector) to help them find effective and innovative ways to address the growing costs of protecting public health and the environment in a sustainable manner. EFCs will be established across the nation to provide regulated parties with financerelated training, technical assistance, finance studies, and other analytical support (eligible services) to help them develop solutions to the critical "how-to-pay" issues associated with meeting environmental goals. Ira W. DeCamp Foundation: Over the past 20 years, the DeCamp Foundation's grantmaking has supported a wide array of organizations within three major program areas in the New York metropolitan region: community-based health care, foster care, and workforce development. Non-profit organizations classified as 501(c)(3) are eligible for annual grants of \$25,000 to \$250,000 for capacity-building, project, and capital support. Department of Treasury: The Volunteer Income Tax Assistance (VITA) program is designed to prepare and file federal tax returns for underserved populations in hard-to-reach areas, both urban and non-urban; increase the capacity to prepare and file federal tax returns electronically; heighten quality control; enhance training of volunteers; and significantly improve the accuracy of returns prepared at VITA sites. The program is open to public and private institutes of higher education and non-profits with 501(c)(3) status with the IRS. Department of Treasury: The IRS is authorized to enter into agreements with private or non-governmental public non-profit agencies or organizations with 501(c)(3) status through the Tax Counseling for the Elderly program. The grants will fund these organizations to provide training and technical assistance to volunteers who provide free tax counseling and assistance to elderly individuals in the preparation of their federal income tax returns. Grant funds are used to reimburse volunteers for out-of-pocket expenses including transportation, meals, and other expenses incurred by them in providing tax counseling assistance at locations convenient to the taxpayers. Brown Rudnick Charitable Foundation Corporation: A nonprofit tax-exempt entity established by attorneys from Brown Rudnick Berlack Israels LLP, has launched a Community Grant Program. The program to simultaneously (1) encourage those involved broadly with the Brown Rudnick Center for the Public Interest to actively think about the educational needs in the communities of Boston, Hartford, New York City, Providence and Washington, D.C., (2) recognize, encourage and collaborate with the front-line workers within the educational system who often do not have a voice in funding decisions, and (3) provide funding to assist with small, concrete projects or need which will make an improvement in inner city education within a year of the award. The Foundation generally considers grant applications monthly and award grants in an amount totaling not more than two thousand dollars (\$2,000) in any one month. The applicant must be a "front line educational worker" who is involved in the education field or a related field applying for a non-profit organization or tax-exempt organization (e.g. a public school) that is willing to accept the grant and use it in the required manner. The proposed use of the grant must be to fully fund a specific, one-time future educationrelated need or idea which promises to improve inner-city education within one year of the grant award.
