

21	GENERAL PROVISION—THIS DIVISION
22	Sec. 101. Sections 143, 144, and 145 of division A
23	of the Consolidated Security, Disaster Assistance, and
24	Continuing Appropriations Act, 2009 (Public Law 110-
25	329; 122 Stat. 3580 et seq.) are each amended by striking

1	Sec. 102 . (a) Extension of Commission on the
2	PREVENTION OF WEAPONS OF MASS DESTRUCTION PRO-
3	LIFERATION AND TERRORISM.—Effective as of February
4	1, 2009, section 1858 of the Implementing Recommenda-
5	tions of the 9/11 Commission Act of 2007 (Public Law
6	110-53; 121 Stat. 504) is amended—
7	(1) in subsection (a), by striking "60 days
8	after" and all that follows through the end of the
9	subsection and inserting "on March 1, 2010."; and
10	(2) in subsection (b), by striking "the 60-day
11	period referred to in subsection (a)" and inserting
12	"the period beginning on February 2, 2009, and
13	ending on February 28, 2010,".
14	(b) Funding.—Of the funds provided under the
15	heading "Operation and Maintenance, Defense-Wide" in
16	the Department of Defense Appropriations Act, 2009 (di-
17	vision C of Public Law 110–329; 122 Stat. 3606),
8	\$1,100,000 shall be made available only for purposes of
9	the Commission on the Prevention of Weapons of Mass
20	Destruction Proliferation and Terrorism.
