Project Description: The Schuylkill River Valley National Heritage Area Management Plan adopted by the heritage area and endorsed by the Department of the Interior focuses on building a regional identity, construction & promotion of the Schuylkill River Trail, establishing a series of gateway information centers in partnership with the National and State Parks and other non-profit conservation, recreation, historical or tourist entities. It also addresses two large projects: the construction of the Schuylkill River Interpretive and Education Center in partnership with the Montgomery County Community College and the establishment of the Schuylkill River Restoration Fund in partnership with the public and private sector. Southeastern Pennsylvania has some of the most significant historical, cultural and conservation amenities in the U.S., many of which are nationally significant. These include Independence National Historical Park; Valley Forge National Historical Park; Mill Grove, the home of John James Audubon; the birthplace of Daniel Boone; Hawk Mountain Sanctuary; the Schuylkill River and many others. Funds from both the Schuylkill River Valley National Heritage Area and the PA Department of Conservation & Natural Resources are also playing a role in preservation and conservation projects.
