9 amendments. The Senate amendments shall be considered  
10 as read. The motion shall be debatable for one hour, with  
11 50 minutes equally divided and controlled by the chair and  
12 ranking minority member of the Committee on Natural  
13 Resources and 10 minutes equally divided and controlled  
14 by the chair and ranking minority member of the Com-  
15 mittee on Ways and Means. The previous question shall  
16 be considered as ordered on the motion to its adoption  
17 without intervening motion or demand for division of the  
18 question.
