- 19 and the chair and ranking minority member of the Com-
- 20 mittee on Ways and Means. The previous question shall
- 21 be considered as ordered on the motion to final adoption
- 22 without intervening motion.
- SEC. 2. It shall be in order at any time through the
- 24 legislative day of October 1, 2010, for the Speaker to en-
- 25 tertain motions that the House suspend the rules. The

- 2 Leader or his designee on the designation of any matter
- 3 for consideration pursuant to this section.
